



**PUBLIC PATH EXTINGUISHMENT AND
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (FOOTPATH 85, PARISH OF MYDDLE, BROUGHTON
AND HARMER HILL) PUBLIC PATH EXTINGUISHMENT ORDER 2018**

This order is made by The Shropshire Council (“the Council”) under section 118 of the Highways Act 1980 (“the 1980 Act”) because it appears to the Council that the footpath described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of the event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

BY THIS ORDER:

The public right of way over the land situate at Burlton Lane Farm in the Parish of Myddle shown by a continuous bold line on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it those public rights of way, and upon the occurrence of the extinguishment the Shropshire definitive map shall be modified by deleting from it those public rights of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.

1. Notwithstanding paragraph 1 of this order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

Where immediately before the date on which the footpaths are extinguished there is

apparatus under, in, on, over, along or across them belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

SCHEDULE

PART 1

Description of Public Right of Way Extinguished

The full width of Footpath 85, Myddle, Broughton and Harmer Hill, to be extinguished from point A on the Order Map (SJ 4620 2534) where it leaves the county road running in a general north easterly direction across agricultural land to point B on the Order Map (SJ4639 2551); a total distance of approximately 273 metres.

PART 2

Modification of Definitive Statement

There is no Shropshire definitive statement for Footpath 85, Myddle, Broughton and Harmer Hill.
