

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER**

**THE SHROPSHIRE COUNCIL (FOOTPATH 3 (PART))
PARISH OF MORETON SAY) PUBLIC PATH DIVERSION ORDER 2023**

The above order was made on 20th July 2023. The effect of the order will be to divert

The full width of that part of FP 3 leaving the Bletchley to Moreton Say Road at point A on the Order map at grid reference SJ 6294 3437 running in a general south westerly direction through an agricultural building then on a natural surface to point B on the Order map at grid reference SJ 6287 3427. A total distance of approximately 121 metres **onto a line** leaving the Bletchley to Moreton Say Road at a gate at point C on the Order map at grid reference SJ 6290 3426 running in a general WNW direction with a defined width of 2 metres to re-join the Definitive line of FP 3 at a gate at point B on the Order map at grid reference SJ 6287 3427. A total distance of approximately 34 metres.
