Dear Jacques,

Thank you for arranging the meeting on the 21st March. I think it will need to be the best part of a day split between site and view points and then afternoon discussions about mitigation. If you could let me know how many people are coming and their field of expertise. For the purposes of this application I am just plain Claire! This is because, as I am sure you are aware, I am impacted by your proposal.

I wanted to outline some of the concerns so that we make best use of the time.

We have divided ourselves up into groups, each group is looking, in depth, at the main material planning considerations of this application.

The visual impact of this application will seriously affect a considerable number of residents. A 10 metre buffer zone around the site, planting to be agreed and the fencing the panel side of the buffer zone, has been suggested. This would certainly help mitigate the impact for Berrington residents. Cantlop is much more difficult and we would appreciate some input from yourselves. It would be helpful if you took on board these concerns and that these are reflected in your updated plans that you present on the 21st March. This would be at least be a starting point. I understand that Hugh has asked for your initial view points and we can discuss this further on the 21st. The intention is to walk around the view points with yourselves and agree the various locations. There is an opportunity for meaningful dialogue on the 21st. In the meantime we have engaged a photographer to help us assess the view points.

Suitability of the site is also a concern. We have our own team checking the levels and calculating the slopes etc. plus an agricultural assessment.

The impact on heritage assets has also raised concerns due to the topography of the site.

Traffic during the construction phase will need to be conditioned very tightly and I will explain my concerns in more detail when we walk the site. There may be an opportunity for management of traffic in the longer term and a solution for the notorious Sandy Bank which has a habit of periodically collapsing! This would reduce traffic in the long term through the Village and provide a real community benefit.

In a scheme of this size you will no doubt be expected to provide substantial community benefits by the LPA. There are various examples of this as I am sure you are aware.

This project will have a detrimental impact on at least 40 properties in the area and has caused considerable worry for the most impacted residents. It is important that we have a morning of walking around the site and visiting the various view points. We can then spend the afternoon discussing various options for mitigation.

I look forward to meeting you on the 21st March, in the meantime please feel free to contact me if you have any questions.

Thank you for arranging the meeting on the 21st March. I think it will need to be the best part of a day split between site and view points and then afternoon discussions about mitigation. If you could let me know how many people are coming and their field of expertise. For the purposes of this application I am just plain Claire! This is because, as I am sure you are aware, I am impacted by your proposal.

I wanted to outline some of the concerns so that we make best use of the time.

We have divided ourselves up into groups, each group is looking, in depth, at the main material planning considerations of this application.

The visual impact of this application will seriously affect a considerable number of residents. A 10 metre buffer zone around the site, planting to be agreed and the fencing the panel side of the buffer zone, has been suggested. This would certainly help mitigate the impact for Berrington residents. Cantlop is much more difficult and we would appreciate some input from yourselves. It would be helpful if you took on board these concerns and that these are reflected in your updated plans that you present on the 21st March. This would be at least be a starting point. I understand that Hugh has asked for your initial view points and we can discuss this further on the 21st. The intention is to walk around the view points with yourselves and agree the various locations. There is an opportunity for meaningful dialogue on the 21st. In the meantime we have engaged a photographer to help us assess the view points.

Suitability of the site is also a concern. We have our own team checking the levels and calculating the slopes etc. plus an agricultural assessment.

The impact on heritage assets has also raised concerns due to the topography of the site.

Traffic during the construction phase will need to be conditioned very tightly and I will explain my concerns in more detail when we walk the site. There may be an opportunity for management of traffic in the longer term and a solution for the notorious Sandy Bank which has a habit of periodically collapsing! This would reduce traffic in the long term through the Village and provide a real community benefit.

In a scheme of this size you will no doubt be expected to provide substantial community benefits by the LPA. There are various examples of this as I am sure you are aware.

This project will have a detrimental impact on at least 40 properties in the area and has caused considerable worry for the most impacted residents. It is important that we have a morning of walking around the site and visiting the various view points. We can then spend the afternoon discussing various options for mitigation.

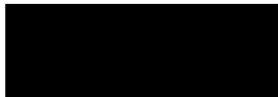

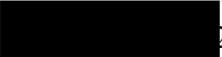



A wide range of potential viewpoints were investigated in the desk study using Google Earth and these will eventually form the basis for the Visual Assessment.
