**THE SHROPSHIRE COUNCIL (FOOTPATH 20 (PART) & FOOTPATH 21 (PART),  
PARISH OF PIMHILL)  
PUBLIC PATH EXTINGUISHMENT ORDER 2024**

This order is made by The Shropshire Council ("the Council") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that the described in paragraph 1 below is not needed for public use.

This Order is also made under section 53A (2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of the event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the stopping up (as authorised by this Order) of a highway hitherto shown or required to be shown in the map and statement.

**BY THIS ORDER:**

1. The public right of way over the land situated in the parish of Pimhill shown by a continuous bold line on the map attached to this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way, and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way, and the definitive statement shall be modified as described in Part 2 of the Schedule to this order.
2. Notwithstanding paragraph 1 of this order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

Where immediately before the date on which the footpath is extinguished there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

## **SCHEDULE**

### **PART 1**

#### **Description of Public Right of Way Extinguished**

##### **Footpath 20 (part)**

The whole width of footpath 20 (part) from grid reference: SJ 4720 1972 running in a general northwest then a north-north-west direction to grid reference: SJ 4714 1980. An approximate distance of 103 metres.

##### **Footpath 21 (part)**

The whole width of footpath 21 (part) from grid reference: SJ 4737 1936 running in a general north-north-west, then westerly, then north-north-west, then northerly direction to the junction of public footpaths 20 and 21 at grid reference: SJ 4727 1957. An approximate distance of 253 metres.

### **PART 2**

#### **Modification of Definitive Statement**

None, as there is no Shropshire Definitive Statement for the remainder of these Rights of Way.

#### **Variation of Particulars of Path or Way**

None, as it is intended to extinguish these Rights of Way.

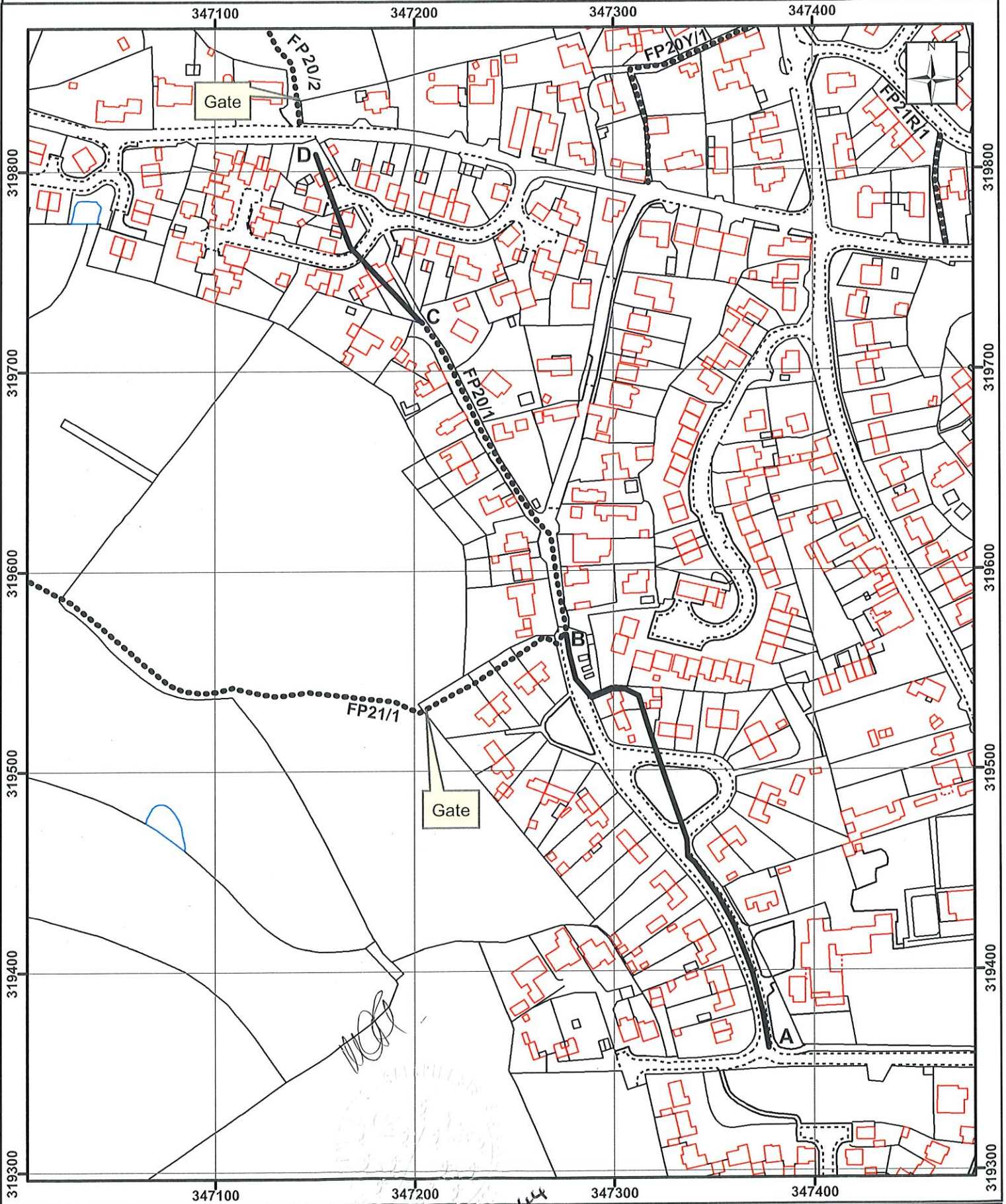
