### 1. Off Street Car Parks.

### **Current charges:**

Bridgnorth charges for most of its car parks, with 980 spaces in 5 main car parks.

### **Proposed charges:**

The proposals is to standardise the charges in Bridgnorth car parks, where there is currently a different tariff on a Saturday to rest of the week. This includes some weekday increases, from 50p per hour to 80p per hour. (although these car parks currently have no hourly tariff as such with the minimum charge at £1, therefore this offers more choice to the short stay visitors). Some of the Saturday charges will be reduced.

We propose an increase to the all day charge at Smithfield and to keep a lower all day rate at two other car parks (totalling 278 spaces) at £2.20. This is to encourage commuters to use these car parks and keep the central area car parks available for shoppers and visitors.

Charges for up to 4 hours parking will remain the same in Smithfield car park.

Some charges have been reduced on Saturdays, to bring in line with general policy for a flatter charging structure across the county. This makes it easy for the public to understand and less administrative cost to operate. These charges are in line with those for the other larger market towns, but lower than Shrewsbury car park charges.

Season tickets will be available at a discounted rate. The formula will apply to a full day ticket at 200 days per year, with a discount of 25% for an annual permit, a 20% discount for a 6 month permit and 10% for a 1 month permit. Season tickets will only be available for long stay car parks.

It is proposed to charge Monday to Sunday 8am – 6pm.

A charge for disabled badge holders will apply in car parks, on street will remain free.

### Sainsbury car park.

Sainsbury currently reimburse the charge to park. We will discuss any changes to the tariff to ensure this arrangement remains.

West Gate (council offices) car park is currently available for public parking on Saturday and Sunday, with a charge of £2.50 all day. It produces very low income and because it is some distance from the town centre it is proposed to make this free.

### 2. On street car parking

No on-street charges proposed – it is proposed to continue to provide up to 45mins free parking, where there are existing on-street spaces.

### 3. Coach Parking.

Coach parking will now be free in all suitable Shropshire Council car parks, but HGV charges will remain.

### 4. Residents parking zones.

A number of different residents parking permit charges were in place. There are currently running experimental orders in a number of RPZ locations in Bridgnorth. The aim is to bring these in to line with our policy in parallel with the wider consultation. It is intended that all households in defined Residents Parking Zones are eligible for up to 2 permits per household to park in designated on-street resident parking areas, with a charge per permit of £50 each pa.
