I, Susan Sharp of the above address, hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 modifying the definitive map and statement for the county of Shropshire by adding the footpath from Eagle Lane, Cleobury Mortimer at grid reference SO675756 to Cleobury Mortimer FP55 at grid reference SO67676 as shown on the attached map.

I attach 10 evidence forms completed by witnesses showing use of this path from before 1987 to date.

In the early 1990s, the local voluntary footpath group (CMFA) mistakenly erected a stile and finger post at Eagle Lane in the belief that it was a right of way. No landowner has ever objected to this.

I also advise you that I have fulfilled the requirements of paragraph 2 of Schedule 14 to the Wildlife and Countryside Act 1981 in connection with this application, in that I have notified both landowners involved of my intention to apply for this modification.

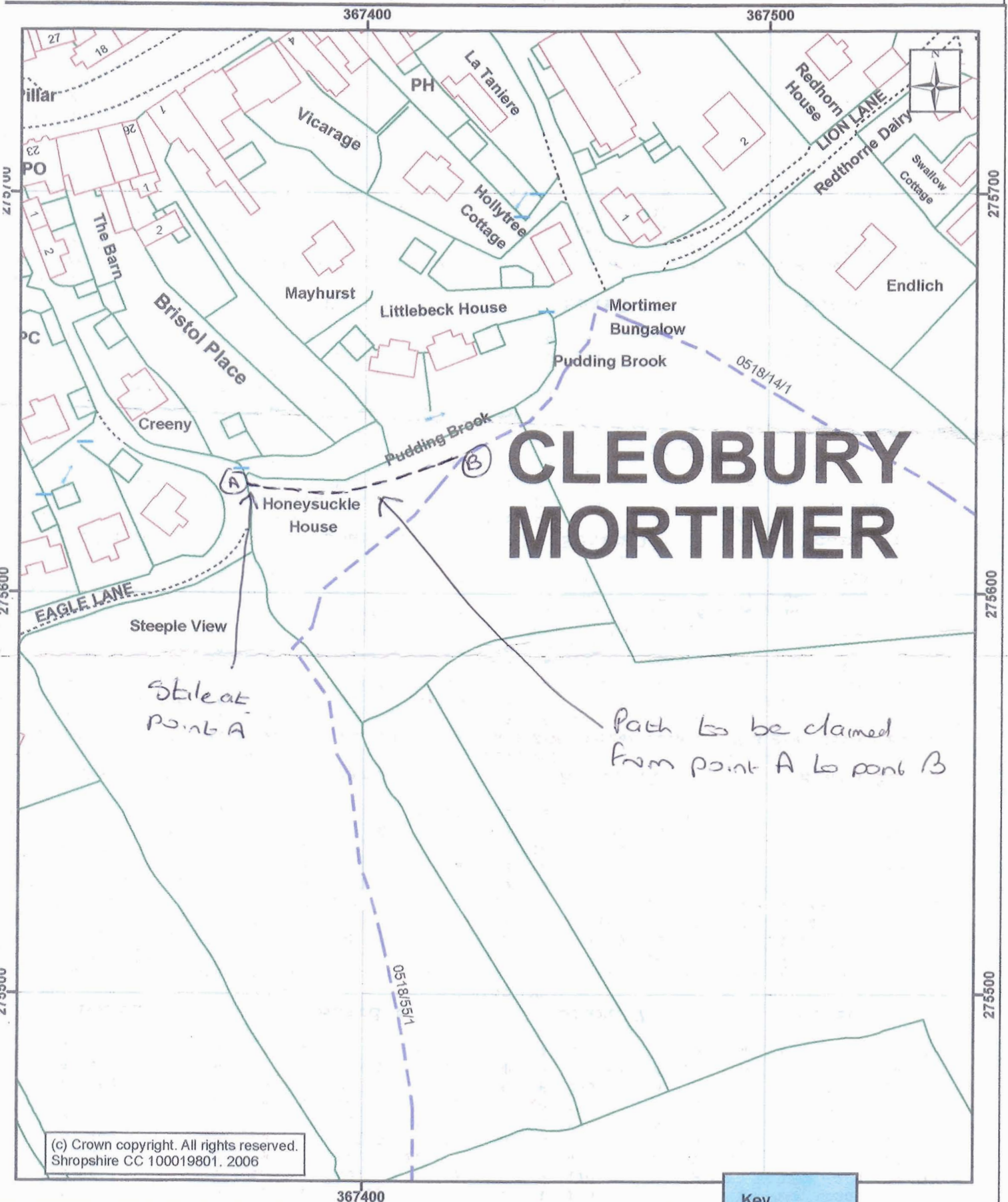
