## Summary

This paper seeks Cabinet approval for the delegation of grant approvals to the Shropshire Hills Area of Outstanding Natural Beauty (AONB) Partnership, acting as the "Local Action Group" for delivery of LEADER funding in the Shropshire Hills area.

#### Recommendations

## Report

- 1. Shropshire Council acts as the accountable body for delivery of LEADER grant funding (part of the Rural Development Programme for England) in the Shropshire Hills area. This is totally externally funded. The Shropshire Hills AONB Partnership acts as the "Local Action Group" providing the necessary partnership structures and engagements. Councillors Tim Barker, James Gibson, Heather Kidd and Cecilia Motley sit on the Partnership Board of the AONB.
- 2. The governance requirements of LEADER involve a Memorandum of Agreement between the Local Action Group and the accountable body Shropshire Council.
