Mr Michael Wilkinson	<p>3.4 Granting a Waiver The Act contains provisions that permit the Council to grant a waiver from the requirement to hold a sexual entertainment licence. The Council does not, however, consider that it would be appropriate to grant such waivers, particularly as the legislation allows relevant entertainment on infrequent basis of no more than eleven occasions within a 12 month period.</p> <p>It would appear that while Government has made a provision, council considers it inappropriate and will ignore it. If council can ignore one part of the counties legislation/ guidelines what is to stop it ignoring all of them?</p> <p>I consider the term sex shops as totally inappropriate, they do not sell sex.
