# LOTON AND TERN LOCAL JOINT COMMITTEE – PLANNING MEETING FUNDING REPORT

#### 1. Summary

In 2012/13 this Local Joint Committee has a total budget of **£18,968** available to spend. This is made up of £17,000 from the LJC budget, £1,118 from the arts funding and £850 carryover from 2011/12.

The Committee have approved grants totalling £9,001.34 so far in this financial year, leaving **£9,966.66** in the 2012/13 budget.

This report outlines the applications received since the LJC meeting. The basic grant criteria of the LJC is that projects can apply for grants of up to £350 without needing matched funding; or grants of between £351 and £2,000 provided a minimum of 50% matched funding is secured. The maximum grant available from the LJC is normally restricted to £2,000.

Where matched funding is required for a project this must be in the form of cash, as in kind support is not accepted as matched funding

#### 2. Recommendations

A. Members are asked to support the applications 10.13 to 10.18 at the grant levels requested by the applicant.

All the applications listed below have undergone a basic appraisal and meet the LJC requirements regarding having their own bank account, constitution and have submitted sufficient quotes with their applications.

LJC10.14	Westbury Youth Club	This project is to help meet the start-up costs of a new youth club in Westbury for young people aged 11 -15 years of age, in a safe, stimulating environment. The aim of the club will be to encourage young people into sports, computers, crafts and activities and to also hear presentations by visiting speakers about issues such as alcohol abuse, road safety, and other issues affecting teenagers. 		tennis, cricket, basketball, football, pottery, graphic design, arts and drama. This grant will help pay for materials and equipment for the club.			
LJC10.15	Nesscliffe Winter Lights	To provide support to a community group in Nesscliffe to run and manage their Christmas lights. The Crescent in Nesscliffe hosts an annual Christmas Lights event where homes are decorated and people visit the site to view the lights. The funding will be used to purchase public liability insurance for the event and stewarding	£122	£122 (100%)	
LJC10.16	Wattlesborough Pre School and Village Hall	Wattlesborough Pre-school and Wattlesborough Village Hall have both applied to the LJC to request support for their respective organisations. It is proposed to offer Wattlesborough Pre School a grant of £2,000 on the condition that this funding is used solely to pay for the groups hire of Wattlesborough village hall by the pre school group	£2,000	£2,000	
LJC 10.17	Bomere Heath Toddlers Group	This project is to purchase new equipment for toddlers group which meets twice a week in the village and attracts 10-12 toddlers and parents to each session. The new equipment will be a mixture of toys and games to broaden the range of play at the group which is an improvement identified in their latest report	£350	£350	

LJC 10.18	Alberbury Cricket Club – Purchase of new roller	Alberbury cricket club run 3 senior teams, 1 midweek league team and 4 youth teams and are an English Cricket Board (ECB) Club Mark accredited club. To extend the training they can provide at the club they are looking to upgrade their facilities, starting with the purchase of a new roller for their pitch. The improvement made to pitches as a result of the roller will extend the training available each week.	£4,800	£2,000 (41% of project costs)	Matched funding of £2,8000 has been secured from the clubs own funds.

All applications in this report have been subject to an initial officer appraisal to check they meet the basic LJC funding criteria and that suitable quotes and bank details have been submitted with the applications.
