1 Election of Chairman

2 Welcome and Introductions

The Chairman welcomed everyone to the meeting.

3 Election of Vice Chairman

Resolved: That Councillor Betty Carlyle be elected Vice Chairman for the ensuing municipal year.

4 Apologies for Absence and notification of Substitutions

5 Declarations of Interest

Councillor Barry Bennion declared a personal interest in the Funding Applications Report (Minute Number 10) in respect of the application from Upton Magna Parish Council as he had been heavily involved in the application.

Councillor Roy Griffiths declared a personal interest in the Funding Applications Report (Minute Number 10) in respect of the application from Alberbury Village Hall Committee as he was Vice Chairman of the Village Hall Committee. He did not vote on determination the application.

6 Notes of Previous Meeting

RESOLVED: That the notes of the meeting held on 21 June 2012 be confirmed and signed by the Chairman as a correct record.

7 Local Policing Update

No issues were raised in respect of any local policing matters.

8 Resolutions from Parish Councils

None received.

9 Area Director's Update

The Chairman welcomed George Candler Area Director (North) to the meeting. Mr Candler gave two presentations to the meeting in respect of the forthcoming changes to working practices and service provision by Shropshire Council namely Strategic Commissioning and the future ways of working via the newly established company ip&e (copies attached to the signed minutes).

Mr Candler outlined how the Council's services would be commissioned in the future and explained the change in the way services would be delivered and confirmed that the company would be known as 'IP&E -Inspiring Partnerships and Enterprise' and as such the company would be expected, through the Council as a strategic commissioning organisation, to deliver services differently to by offering improved services at a lower cost to council tax payers. He went on to explain that the Council was now able to set up a trading company with the ability to create 'public profit' which would be used to reinvest in improving local services and confirmed that Shropshire Council would always retain 51% of the company but could partner up with other bodies to bring on board other expertise. This new company had been created in response to the need for Shropshire Council to achieve savings of up to £86m over four years. Savings of £46m over the last two years had been achieved, despite there being no increase to Council Tax and with no cuts to service provision. However, further cuts to the Government grant of up to 30% in 2014/15 were expected and, unless the Council came up with new service delivery vehicles to fund and deliver services in Shropshire, it was likely that non-statutory services would be cut in future.

Mr Candler explained how the strategic commissioning framework would be delivered and it was expected to provide lots of benefits for the voluntary and business sectors and that the Council would be able to commission services from others than directly providing services thereby giving more freedom in how services were provided as long as agreed outcomes were achieved.

Mr Candler was thanked for this attendance and input into the meeting.

10 Loton and Tern Local Joint Committee Funding Applications

The Community Action Officer presented his report setting out details of four funding bids which had been received since the previous meeting on the 1 March 2012.

- 1st Bomere Heath Beaver Scouts application for funding the setting up of the 1st Bomere Heath Beaver Scouts Beaver Colony in Bomere Heath - £541.34
- Alberbury Village Hall Committee application for funding towards the purchase of a new hearing loop system in the Village Hall -£1,500.00
- Upton Magna Parish Council application for funding towards the upgrading of the street lighting in the Parish - £1,800.00
- Bicton Explorer Scouts application to help in meeting the costs of the 2012 Summer Camp trip - £400.00

It was agreed that Ron Buzzacot be invited to attend the next meeting in order that the matter could be discussed and residents' concerns be expressed. LS / MM

Shropshire Council Traffic Technicians met with representatives from the Highways Authority and Amey (contractors) to highlight the numerous concerns in respect of Emstry Island and its approach from London Road and Atcham. A request has been made to the Highways Agency for further consideration be given to managing the lane designation on Emstrey Island and the London Road approach issues.
