Other local Parish Paths Partnership Groups, the Shropshire Riding & Carriage Driving Groups and the Local Access Forum support this proposal, and it is in accordance with the needs identified in the Countryside Access Strategy for Shropshire 2008-2018.

The route which will form part of the 'Ride Shropshire' network will use existing bridleways to create the main route and circular rides off, one of which includes a public bridleway recently dedicated by three local landowners. The route has parking, pubs, village shops and equestrian and other businesses etc. on and near the routes, and it links rural communities and Shropshire Council Parks and Countryside sites.

'Wild' Humphrey Kynaston, was the 'Robin Hood' of Shropshire and the route connects places relevant to his history and other places of interest.

The work required will be:

- Some grounds works and improvements to furniture
- Bespoke signposting and waymarking
- Producing and printing guide leaflets
- Adding downloadable routes and maps to the existing riding website
