## Section 2: Project Description

An old railway line running from Much Wenlock to Farley is under the ownership of two landowners. The Willey Estate is the principal owner but Shropshire Council owns a significant section where it lies within the town of Much Wenlock. Two nationally important routes, The Jack Mytton Way and the Shropshire Way follow parts of the route but it is not recorded as a public right of way. Access to the railway for horseriders and cyclists who are following the Jack Mytton Way crosses land owned by a third party, Wenlock Estates.

In response to a proposal to stop up an adjacent footpath community groups expressed a wish for the railway line to be recorded as a public right of way and for a footpath link to be provided running to the Farley Road to enable the use of a local circular walk.

Although the Jack Mytton Way follows the old railway it is currently difficult to use due to overgrowth and attention to the surface is required to make it sustainable for multipurpose use. As it is an old railway line the gradient and surface, if improved would, offer a continuation of an all ability route which has recently been developed on Council land at the southern end of the route.

The project has been approved by the Local Access Forum

The route would enhance access from the urban centre to the surrounding countryside.
