TRAINING FOR PARISH/TOWN COUNCILS 2010

Summary

This report provides some feedback on training offered to members and officers of Parish/Town Councils in Shropshire, as part of a rolling programme, during the spring and summer 2010.

Recommendations

A. That the report be noted and that the production of a DVD as a tool in connection with training for parish/town councils be endorsed.

REPORT

- 1. Members will recall that at the last meeting of the Committee, it was agreed that further training in ethics and probity for all parish/town councils should be provided as part of a "rolling programme" across Shropshire. Furthermore this training would be arranged on a "cluster" basis in certain geographical areas and/or with those parish clerks who were responsible for more than one council.
- 2. The "rolling programme" of training for parish/town councillors resumed in February 2010 across the County, with some eight sessions being held over a five month period.
- 3. The information shown below gives dates, venues and attendance figures for each of the training sessions held. The training sessions were conducted by the Monitoring Officer and/or the Deputy Monitoring Officer and the Monitoring Officer's staff and covered ethical governance and decision making; the Code of Conduct and its implications for parish/town councillors; and the procedures to be followed in the local assessment of complaints about member conduct.

- 4. A representative of the Association of Local Councils was invited to attend each of the above mentioned training events.
- 5. With regard to the training sessions in (ii) (vii) above personal invitations were sent to all parish/town councillors and clerks for each of the 40* parish/town councils listed. This totalled some 423. Actual attendance figures amounted to 146 for these six sessions.
- 6. Persons attending the various training sessions have commended the Monitoring Officer and her staff for the seminar content and quality which they found to be enlightening and relevant to their roles as parish/town councillors.
- 7. During this month it is the intention, in accordance with the wishes of the Committee, to produce a DVD for training purposes. Copies of the DVD can then be distributed to all parish/town councils for their use at meetings/dates suitable to them. This should assist in reaching an even larger audience for ethical governance issues.

Staff of the monitoring office will still be available to deal with any queries and/or provide advice on the Code of Conduct Ethical Governance and the procedures for dealing with complaints about member conduct.
