Summary

Licensing officers have delegated powers to issue or amend licences, providing no objections have been received. This report gives details of the issue of licences, or variations, that have been issued between 1st January 2011 and 31st July 2011 and also shows some comparative figures for the same period the previous year. The report also gives a summary of applications considered by committee.

REPORT

Risk Assessment and Opportunities Appraisal

This is an information report giving Members information on the work undertaken by the Licensing team and Committee and therefore a risk assessment and opportunities appraisal has not been carried out.

There are no financial implications associated with this report.

Background

At the Strategic Licensing Committee meeting in March 2010 it was agreed that information regarding the issue of licences by Officers under delegated powers would be reported to Committee.

Delegated powers have been given to officers where a licence has been requested and there have been no objections raised by interested parties or

Responsible Authorities or the application has met the Council's policy criteria for accepting an application. In these cases the Licensing Authority has no alternative but to issue the licence.

The table in Appendix A shows the complete range of licences issued by the licensing team during the period 1st January 2011 to 31st July 2011. Some comparative figures for the same period in 2010 have been included in brackets, so that members can note the increase in work load during this calendar year. This, as can be seen in the table, relates mainly to the influx of taxi and private hire driver and vehicle applications from outside the area.

It is worth noting that whilst the number of applications has increased, the number of staff in the team has reduced from 16.1 Full Time Equivalent (FTE) in 2010 to 11.3 FTE in 2011. The service has been reviewed to improve processes and efficiency.

With the increase in applications there have also been an additional number of referrals to Committee with the associated reports. A table is included in Appendix B showing the number of driver and vehicle applications addressed at the various committees in 2011.

The Licensing Act activities at Committee have also been given in Appendix C for this calendar year.

Additional Information

Applications are being submitted for hackney carriage and private hire vehicles from outside the area along with the continuing influx of driver applications.

Conclusions

Solutions are being sought to balance officer work load against budgetary constraints to maintain a responsive and efficient service for our customers.
