Monitoring visit 18/9/2013

The local authority acted with urgency to ensure that the school was provided with effective leadership and management which would raise staff morale, improve communication with parents and accelerate pupils' progress. The local authority has supported senior leaders in putting together a comprehensive plan for improvement and has organised a range of supporting activities to help senior leaders and governors continue to improve the school.

The local authority has provided additional support to improve achievement and leadership over time, although governors say that this advice was not always used by senior leaders. The new headteacher now works effectively with governors and the local authority's school improvement adviser.

### Monitoring visit 18 June 2013

The local authority's statement of action sets out how its officers will work with you to bring about the required improvements. The support from the National Leader of Education has been brokered and advisers for English, mathematics and assessment, among others, are scheduled to work with you and your staff. The support is measured and appropriate. The LA's statement of action is fit for purpose.

### **Monitoring visit 15 October 2013**

The school has benefited from good input from both the local authority's advisers and consultants and the national leader in education. They have provided a good balance of support and challenge that has helped improve the quality of teaching and outcomes for pupils in mathematics and supported developments in leadership.

The local authority and the headteacher agreed that the school is causing concern. The high level of support provided for school leadership and mathematics teaching has not been successful in dealing with the underachievement of pupils across the school.

## Monitoring visit 26 June 2013

Teachers have responded well to the support and additional training provided by a mathematics adviser to improve their subject knowledge, as well as the support of other local authority or independent consultants and the acting deputy headteacher (both brokered by the LA). The appointment of an acting deputy headteacher, seconded from an outstanding primary school in the local authority, has had an immediate impact on improving teaching and the school's monitoring systems. Recent appointments, including that of a permanent deputy headteacher who joins in September 2013 and who has a strong track record of school improvement as endorsed by the local authority, have strengthened leadership capacity further. The local authority provides good support and a wide range of services involving consultants and subject advisers to work alongside staff and leaders. In addition, the use of Local Leaders in Education, the school's improvement adviser and the secondment of an acting deputy headteacher, have helped to focus on improving the quality of teaching.

## **Monitoring visit 3 October 2013**

The headteacher is working closely with local authority subject advisers and with partner schools in the Lichfield Diocese to provide a systematic programme of support, coaching and mentoring for staff. The local authority's school improvement adviser has commissioned a good range of helpful support for teachers and leaders. This support involves training for governors and staff, as well as subject advisers working with teachers who have management responsibilities. The local authority's support has been effective.

The school has had valuable support from the local authority's school improvement adviser, and has received additional support from the local authority. However, the relationship between the school's leaders and the local authority is not as productive as it should be to bring about the rapid and sustained improvement needed.

### **Monitoring Visit 25 April 2013**

The interim executive board is working closely with you and the local authority. It is clear that all parties know exactly what is expected of them, and how they will be held accountable. Following The local authority's statement of action is fit for purpose.

#### **Monitoring Visit 18 September 2013**

The strong and well-focused support provided by the senior leaders and staff of The Marches School, together with that of the local authority, has been pivotal to much of the improvement in leadership and teaching that has been seen. In addition, the local authority has provided a thorough and honest evaluation of the school's progress so far.

Appendix C: extracts from primary school inspection reports where schools moved from satisfactory to good, or from inadequate to good (and therefore were removed from a judgement of Special Measures)

Primary 2/3 October 2013 Satisfactory Good

The local authority has a good knowledge of the school and provided strong support in the past. As a result of the school's continued improvement, it now provides 'light touch' support.

Primary 7/8 November 2013 Satisfactory Good

Through a strong and positive relationship with the local authority, the school has developed a range of productive and supportive local partnerships. These include: the headteacher using her experience and expertise to help other school leaders; the sharing of good practice in the Early Years Foundation Stage with other schools; and members of the school's support staff who have had specialist training in helping pupils with speech and language needs sharing their skills through the local authority's website.

Primary 13/14 November 2013 Satisfactory Good

The local authority has given good, timely support. For instance, training has been provided and advisers have worked alongside subject leaders to help them develop their roles. Leaders are now confident in many of the tasks they need to carry out, including using data to check on the effectiveness of their subjects.

Primary 1/2 May 2013 Inadequate Good

Local authority support, along with that of the Local Leader of Education from XX Primary School, has helped the school improve. There has been good support for literacy, mathematics, the management of disabled pupils and those who have special education needs, and for the Early Years Foundation Stage. The local authority school improvement adviser is a frequent visitor and has supported the school and governing body to bring about the necessary improvements. Myddle

## **Monitoring visit 24 October 2012**

The local authority supports the school well. Its statement of action is good. It gives clear areas and advice on how the school can improve, including strengthening subject expertise and suitable support for the leadership of the school and the governing body. The attached adviser is a regular visitor and the school has benefited from support from the headteacher and staff at the partner school. Actions by subject consultants have been effective in improving both the quality of teaching and the role of subject leaders.

## **Monitoring visit February 2013**

The local authority continues to challenge the school. It has appropriately scaled down the level of support provided because the school has grown in capacity to manage its own improvement agenda.

### Monitoring visit 19 June 2013

The local authority continues to provide appropriate support and challenge to the school. The local authority has an accurate view of the school's strengths and areas for development. It has provided training to develop mathematical thinking and teachers' marking across the school. The local authority has suggested schools which can share their good practice.

### **Inspection 15/16 October**

The local authority provides timely and good quality support and challenge to school leaders.

The local authority provides light touch support but retains a close relationship with the school. It has provided training for staff and governors and regularly produces reports for governors about the effectiveness of the work of the school.

The local authority works closely with the school on agreed priorities for improvement. The local authority advisor visits termly and has undertaken paired observations, organised additional specialist help to moderate examination coursework in English, supported the governors with the headteacher's performance management and worked with the newly appointed cluster leaders. She also makes use of expertise within the school to provide support and guidance to other schools.

Secondary 9/10 May 2013 Good Requires improvement
The local authority is fully aware of the school's strengths and weaknesses and has worked well with senior leaders.

Secondary 17/18 October 2013 Satisfactory Requires improvement
