REPORT FROM THE HEALTH AND WELLBEING DELIVERY GROUP – FOR INFORMATION -

1. Summary

- 1.1 This report highlights key work of the Delivery Group that is not included as an agenda item. The Better Care Fund is a standing agenda item of the Board, and therefore is not included in this report. The STP, Digital Road Map and the HWBB Audit are also items on this Board agenda so will not be included in this report
- 1.2 Healthy Weight and Diabetes Prevention is progressing on schedule. The work with the Design Council is now complete and the project team is currently undertaking ethnographic research to understand Shropshire people's knowledge and recognition of type 2 Diabetes and its associated health risks. Importantly this research will be used to develop knowledge and appreciation of what motivates Shropshire people when it comes to addressing lifestyle behaviours that increase risk of type 2 diabetes. Partners working together to deliver this project include Shropshire Together, Help2Change, Shropshire Community Trust, and Shropshire CCG. The project is also working closely with 3 GP surgeries (Plas Ffynnon, Cambrian, and South Hermitage) who have come forward to assist with the ethnographic research and share best practice. A stakeholder event is planned for the 30th September. A full report is planned for the November HWBB.
- 1.3 The All Age Carers Strategy consultation closes on 31st July. A working group of the Carer's Partnership Board including Shropshire CCG, Shropshire Council, and the Voluntary and Community Sector, will apply thematic analysis to understand need and develop the strategy and action plan. The final strategy and action plan is due to come to the HWBB in November. Carers is also a key delivery area for the Better Care Fund and as such the Delivery Group will use the All Age Carers Strategy to inform decision making regarding the pooled funds.
- 1.4 The Leadership Centre continues to support the HWBB leadership development. Robin Douglas has met or had phone conversations with most HWB Board members and over August will be working with the Delivery Group to develop a support plan. The key objective of this work is to support the Board and our partners to develop our systems leadership approach in the delivery of the key transformation and integration programmes in Shropshire.
- 1.5 The Delivery Group has recognised that the prevention programmes being developed through the BCF, the HWBB and the STP must be better coordinated in a programme approach. This programme approach will provide clarity on the governance, deliverables,

metrics and associated cost savings. The details of this work are being developed and a full report will be made to the HWBB in September.
