#### 1. Summary

1.1 Where appropriate the Health and Wellbeing Delivery Group implements decisions, actions and the HWB Strategy and the Better Care Fund as required by the Health and Wellbeing Board. This report aims to highlight issues raised at the Delivery Group either for information, endorsement or decision that have not been addressed as their own item at the Board.

#### 1.2 For Information:

- 1.2.1 Housing developing appropriate representation and links across work streams In advance of a wider discussion of housing at the Health and Wellbeing Board in August, Brighid Carey sought to confirm with the group the best way to focus this work.
- 1.2.2 The group discussed the important link of housing in many of the health and wellbeing work streams including the prevention agenda (specifically falls and falls prevention), and confirmed the need to link housing and housing related activity with the Better Care Fund work streams.
- 1.2.3 The group recommended that the report from housing make appropriate focus on the outcomes of the Better Care Fund, particularly the integrated services and prevention work streams.

#### 1.3 For Information:

- 1.3.1 **HWBB Peer Review** The Delivery Group discussed the Peer Review request which has been agreed for January 2015. The group wanted more time to consider the timing and the focus of the review. The request was as follows:
- 1.3.2 The motivation for commissioning a Health and Wellbeing peer challenge During 2013/14 the Shropshire HWBB made excellent effort and progress on establishing positive working relationships across the partnership in order to lay the foundation for working through the service design and redesign that is part of the large scale change that is required in Shropshire; the pieces of work that will bring about this change include the Better Care Fund, the NHS Future Fit and Local Council Service redesign. While progress has been made, the Shropshire HWBB feels there is much more to do to in order to establish itself as a local system leader in Shropshire. As a system leader the Board will have full buy in and participation from all stakeholders (including the public) and will be a trusted Board that makes good decisions for the health economy, delivering real health outcomes for the population, while supporting a whole system approach to reducing inequalities. A Peer Challenge, as the popperstone of the Health and Wellbeing Systems

Improvement Support Programme, will help our Health and Wellbeing Board take the necessary next steps towards this aim.

#### **1.4 For Information:**

- 1.4.1 **Supporting Children with medical conditions in schools** The Delivery Group discussed that the Children and Families Act 2014 will come into effect in September 2014 and in particular <u>Section 100</u> of the Act places a duty on governing bodies of maintained schools, proprietors of academies and management committees of PRUs to make arrangements for supporting pupils at their school with medical conditions.
- 1.4.2 The Group agreed that both Children's Services and the CCG would scope and investigate any current gaps in provision and support on this matter (including medicines management in schools), report to one another and take forward any key actions required.
- 1.4.3 Concerns were raised that this section of the Act made little reference to the Special Educational Needs and Disability reforms, which are a cornerstone of the Act and will likely be relevant to many of the same pupils as section 100 of the Act.
- 1.4.4 In Section 100 Health and Wellbeing Boards are sighted as 'a forum for local authorities and CCGs to consider with other partners, including locally elected representatives, how to strengthen links between education, health and care settings.'

#### 1.5.1 Health and Wellbeing Delivery Plan

1.5.2 The Health and Wellbeing Delivery Plan is under development. The group agreed that some work is needed to bring together the Health and Wellbeing Strategy and the Better Care Fund plan. In light of the large scale transformation programmes across the Health economy in Shropshire, the HWBB must have the tools to lead and be understood as the system driver for across Health and Social Care. This will be discussed in more detail at the HWBB in August.
