26 Welcome and Introductions

26.1 The Chair welcomed everyone to the meeting and introduced David Morgan who had expressed an interest in joining the Committee. Mr Morgan informed the Committee that he was interested in walking and tourism and that he was a volunteer at Lyth Hill and with is local P3 group and also with the Shropshire Wildlife Trust

27 Apologies for Absence

26.2 Apologies for absence had been received from Gareph Boxley, Lee Chapman, Stewart Pickering, Jim Stabler, Stuart West, and Mark Weston

28 Minutes and any matters arising

- 28.1 The minutes of the meeting held on 21 April 2016 had been circulated.
- 28.2 Mrs Robins referred to paragraph 15.4 and commented that she had also referred to the digitisation of the highways maps and asked for an update on this. The Mapping & Enforcement Team Leader advised her that there was no progress to date.

28.3 RESOLVED:

That the minutes of the meeting of the Shropshire Local Access Forum held on 21 April 2016 be approved and signed by the Chairman as a true record.

28.4 Concern was expressed that National Rail were closing routes without making the necessary changes to the definitive map. It was agreed that the Mapping & Enforcement Team Leader should write to Network Rail to remind them of their obligations.

29 Public Question Time

29.1 There were no questions from members of the public.

30 Declarations of Interest

30.1 There were no declarations of interest made.

Outdoor Partnerships Annual Report 2015/16, Enterprise Plan and Shropshire Council Update

- 31.1 Members received a presentation from The Outdoor Partnerships Enterprise Manager (copy attached to the signed minutes) which outlined the teams work and achievements over the past 12 months.
- 31.2 The Outdoor Partnerships Enterprise Manager reminded the meeting that over the past three years the budget had decreased by half and that work was ongoing to try to increase income generating opportunities. She added that work was being carried out with colleagues from the Public Health Department to develop jointly funded projects.
- 31.3 The Outdoor Partnerships Enterprise Manager stated that there was a need to develop the "outdoor economy" and that she was looking into obtaining some funding to enable work to be carried out to work out the value of the "outdoor economy" to Shropshire. Mr Carr commented that this may fit with a piece of work the Ramblers Association was carrying out and that he would look into this further. Mrs Robins commented that The British Horse Society had done a lot of work with respect to the contribution of horse riding to the local economy.
- 31.4 The Chair thanked the Outdoor Partnerships Enterprise Manager and her team for all the work that they had done.

32 Proposal to change the LAF to the Shropshire's Great Outdoors Strategy Board

- 32.1 The Outdoor Partnerships Enterprise Manager advised Members that it was proposed to change the LAF to create the Shropshire Great Outdoors Strategy Board. She stated that the Strategy Board would take on the role of the LAF as well as having a wider role and that the membership would comprise of representatives of user groups, landowners and occupiers, Council representatives, other organisations with relevant interests as well as individuals with specific expertise which may be of use to the Board.
- 32.2 The Outdoor Partnerships Enterprise Manager stated that it was proposed that there would be a number of sub groups made up of members of the Strategy Board and that these groups would be tasked to look at specific topics such as fund raising and income generation.
- 32.3 Several Members expressed broad support for the proposals and stated that it was an opportunity to work in a different way.

- 32.4 Mrs Robins expressed concern that the proposals would move the LAF away from its original aims, and suggested that the Strategy Board could work alongside the existing LAF. She also stated that legislation stated that the membership of the LAF was drawn from individuals rather than representatives of organisations as stated in the proposals.
- 32.5 After further discussion it was RESOLVED:

That the proposals should be progressed and a draft constitution be brought to the next meeting of LAF for approval (4 votes for the proposition and 3 abstentions)

33 Ploughing and Cropping update

- 33.1 Members received a presentation from the Mapping & Enforcement Team Leader (copy attached to the signed minutes) which gave an update on the ploughing and cropping campaign held in 2016.
- 33.2 The Mapping & Enforcement Team Leader advised members that in March letters had been sent to Landowners who had not reinstated rights of way after cropping or ploughing and that the majority of these landowners had been in the north of the County, and that these letters had resulted in approximately 50% of the paths being reinstated or partially reinstated, and that further letters had been sent out in May and June where routes were not reinstated satisfactorily. She stated that further inspections were carried out and thanked volunteers who had undertaken the inspections.
- 33.3 The Mapping & Enforcement Team Leader advised Members that six legal notices had been served and that in five cases immediate action was taken to resolve issues.
- 33.4 Members congratulated the Mapping & Enforcement Team Leader on what had been a very successful campaign.

34 Shropshire Way Main Route

- 34.1 Mr Carr advised the meeting that the consultation into the preferred main route for the Shropshire Way had been concluded and that the preferred route was a figure of eight with Shrewsbury at its centre.
- 34.2 The Outdoor Partnerships Enterprise Manager informed Members that new way markers for the main route would be needed and that to avoid confusion existing way markers would need to be removed.

35 Items for Information/Update, Feedback from other Forums and Future meetings

35.1 The Mapping and Enforcement Team Leader advised that a code of good practice for shooting over rights of way had been developed and was being circulated to members of the CLA, BASC and NFU.

- 35.2 The Outdoor Partnerships Enterprise Manager advised the meeting that a proposal was being developed to change the way the AONB was managed by setting up a Conservation Board which would work independently of the Council.
- 35.3 Members received and noted the following: -

- (iv) Shropshire Riding and Carriage Driving Forum 8 February 2016
- (v) Shropshire Riding and Carriage Driving Forum 6 June 2016
- 35.4 Mrs Robins commented that there was no way of identifying land with higher access rights on maps. The Mapping and Enforcement Team Leader agreed to seek clarification from Natural England
- 35.5 Mr Carr advised Members that Telford & Wrekin Council had finally put in place funding for the production of a definitive map.
- 35.6 Mr Carr informed Members that the owners of Weston Wood which was the subject of a bridleway claim and a number of other issues were putting in place a woodland management plan.
- 35.7 Members were reminded that the next meeting would be held at 10.00am on Thursday, 19 January 2017

Shropshire's Great Outdoors Strategy Board Acting as the Local Access Forum for Shropshire

Constitution

The Shropshire's Great Outdoors Strategy Board acts as the Local Access Forum for Shropshire but broadens the role of this to cover a wider remit in response to current priorities in Shropshire.

The Local Access Forums (England) Regulations 2007 were published by the Department of the Environment Food and Rural Affairs (DEFRA) and came into force on the 19 March 2007. Local Access Forums are required (by section 94 of the CROW Act) to "have regard" to this Guidance when carrying out their functions. The constitution for the Shropshire's Great Outdoors Strategy Board will incorporate these regulations as part of this constitution.

Title

1. The Forum shall be known as the Shropshire's Great Outdoors Strategy Board (the Board).

Geographical Coverage

2. The area covered by the Board is the administrative county of Shropshire, although links will be made across administrative boundaries where this is felt to be advantageous.

Role and Responsibility

- 3. The primary purpose of the Board is to provide advice to the following bodies:
 - the appointing local authority being Shropshire Council
 - Parish and Town Councils
 - Shropshire Hills Area of Outstanding Natural Beauty Partnership
 - the Secretary of State
 - Natural England
 - Forestry Commission
 - Historic England
 - Sport England

Although these are the statutory bodies, the Board will also consider giving advice to other individuals or organisations if it was thought to be beneficial.

4. The Board will give advice to these bodies on:



- how to improve public access in Shropshire (whether on foot, horse, cycle, canoe, mechanically propelled vehicle or any lawful means) for the purposes of open-air recreation and the enjoyment of the area.
- public access in Shropshire for any other lawful purpose which includes 'functional' access to services and amenities (whether on foot, horse, cycle, canoe or by any means other than mechanically propelled vehicle).

The Board will also give advice on:

- Development and promotion of the Outdoor Economy in Shropshire
- · Promotion of the great outdoors for health and wellbeing
- The importance of access to and within outdoor greenspace for community wellbeing and biodiversity
- The natural capital of the Rights of Way network and publically accessible greenspace

The advice from the Board will be independent, constructive, relative, inclusive, incisive and informed. The advice will take account of a broad range of balanced local interests and take account of social, economic and environmental concerns.

The Board will work to:-

- Adopt a constructive and inclusive approach to the improvement of access, outdoor
 economy, health and wellbeing and natural capital which reflects local circumstances
 and the needs of all sections of society.
- Operate within the requirements of the law and locally-set conditions of appointment.
- Provide advice on issues of principle and good practice which is consistent with national guidance.

In carrying out these functions the Board will have regard to:

- The needs of integrated land management, and of environmental, social, economic and educational interests
- The desirability of conserving the natural beauty of the area, including flora, fauna and geological and physiological features
- Guidance issued by the Secretary of State
- Proper liaison with neighbouring authorities
- 5. As Board members are volunteers and give their expertise and experience freely it is recognised that there is a limit to the amount of time members can dedicate to the work of the Board. The Board will prioritise their time by identifying issues which are of special interest or relevance to the area in relation to access and outdoor recreation, which can then be actioned by specific action groups who are focused on these specific activities. These will include:-



- Development of recreation and access strategies which cater for a wide range of people
- Development of a more financially viable model for management of outdoor space and improvements to the Rights of Way network
- Increasing awareness of the importance of outdoor recreation for health, the local economy and the environment
- Influencing and advising other departments, organisations and local and national policy
- Community engagement and volunteering
- Strategic improvements to the rights of way network
- Implementation, management and review of the statutory right of access to the countryside

Membership of the Board

- 6. The role of Board members is to attend Board meetings and to contribute constructively to the role of the Board by:
 - Sharing (and developing) experience, knowledge and skills and the views of any organisation/ network they represent
 - Valuing the contribution of other members, respecting minority views, engaging in constructive debate and seeking consensus where possible
 - Adopting an inclusive approach, which reflects local circumstances and the needs of all sections of society
 - Engaging with the people that they represent (and others) to explain and promote the work of the Board, changing the operation of that organisation or network where appropriate to reflect the advice given
- 7. The membership will consist of no more than 22 members including:-
 - A Chair and Vice-Chair
 - A maximum of 2 elected Councillors (or a maximum of 3 if there are 17 or more other members)
- 8. Board members will represent:
 - Users of local rights of way or open access land (e.g. walkers, horse riders, cyclists, carriage drivers and motorised users)
 - Owners and occupiers of access land or land over which local rights of way subsist
 - Any other interests relevant to the area which could include; nature or land conservation, heritage, health and well-being, tourism and active recreation, local community or minority interests

Preference will be given to those people who represent organisations or networks that have a wide range of experience and knowledge on a cross section of local interests. Membership



of the Board will be balanced to avoid dominance by a single interest group or coalition of like interests.

- 9. The Board will maintain a reasonable balance between the representative groups.
- 10. Members of the Board will be appointed by Shropshire Council according to the selection criteria which assess whether candidates have the authority to represent organisations or networks and have sufficient relative experience to be able to make an informed and constructive contribution.
- 11. Before appointment members will be asked to confirm:
 - Their ability to represent the categories mentioned above, their position within any organisations/ networks they are representing and the willingness of those organisations/ networks to contribute and respond to advice from the Board
 - Their support of the positive purpose of the Board
 - Commitment to working within the constitution and to achieving the aims of the Board through constructive working with other members
 - That they are able to devote the necessary time to attend meetings, progress the outcomes of the Board meetings, attend training and to network with a wide range of interests outside meetings
- 12. Membership of the Board will be for a term of up to 2 years save that:
 - a) At the end of the relevant period any member can be re-appointed
 - b) Any member who does not attend for a period of 1 year without permission may be removed from the Board by the appointing authority
 - c) The Chair in consultation with the Vice-Chair shall be able to recommend to the appointing authority to suspend any Member who is judged to have brought the Board into disrepute.
 - d) De-selection of any member so suspended shall only be exercised following a full vote at the next meeting.
 - e) Should a member of the Board subsequently become a member of a local authority they must inform the Secretary and will be required to step down if the quota of 2 elected councillors' has been filled.
- 13. The Board shall elect a Chair and Vice-Chair from within their membership who should be nominated and seconded.
 - a) If there is more than one nomination the election will take place by way of a secret hallot
 - b) Members present at the meeting will have one vote each and the candidate receiving the most votes will be appointed
 - c) The Chair and Vice-Chair will be drawn from different representative groups
 - d) The term of office for Chair and Vice-Chair should not be for more than two years subject to an annual re-appointment



- e) Members of the appointing authorities should not put themselves forward for either Chair or Vice-Chair
- 14. Meetings should consist of a quorum of eight Board members including at least one member from each of the representative groups. The Chair may suspend any meeting should this quorum not be reached.
- 15. In the event that neither the Chair nor Vice-Chair is available for a meeting then a Chair should be elected from the assembled members for that meeting only.
- 16. Each Member of the Board will have one vote on any issues requiring a decision, which will be by a show of hands. The Chair is to have the casting vote should the need arise.
- 17. Members are required to disclose any personal interest they may have in a matter to be discussed by the Board. Members with a personal interest should not necessarily be excluded from discussion or voting because such members may have a useful contribution to make to the Board's deliberations as long as the nature of the interest is made known to the Board, and recorded as such in the minutes. It will be for the Chair to decide, after consultation with members, if that personal interest is prejudicial to the Board's deliberations on that matter.

Action Groups

- 18. The Board may appoint members to action groups to delivery activity prioritised by the Board. These may be practical actions or to consider any issue within the Board remit. The groups shall:
 - Be made up of individuals relevant to the delivery of that activity, with help from the appointing authority where appropriate and preferably a member of the Board to feedback to the Board as delivery progresses.
 - Make recommendations to the Board on specific issues.

Administration

- 19. Secretariat support will be provided by an officer of the appointing authority.
- 20. Meetings will be held at least twice a year and more frequently where necessary.
- 21. Meeting agendas will be agreed between the Chair, Vice-Chair and the Secretary following consultation with relevant officers where necessary.
- 22. Shropshire Councils normal procedure for advertising meetings will be adopted.
- 23. Agendas, papers and minutes of the meetings will be available to the public.
- 24. The Chair may invite observers to the meeting when appropriate.



- 25. Observers will be able to contribute to the proceedings at the discretion of the Chair.
- 26. Participation of the public:
 - Meetings to be fully open to the public
 - Prior notice should be given by members of the public who wish to ask a
 question, make a statement, or present a petition in line with the Councils
 public question time procedure
 - Public questions will be taken a the relevant point on the agenda at the discretion of the Chair
- 27. The appointing authority will have the right to review the chairing and membership of the Board on an annual basis if necessary.
- 28. The Board shall prepare an annual report on the discharge of its functions.
- 29. The annual report will be published by the Boards appointing authority.
- 30. These rules can be amended by the Board should the need arise subject to the agreement of the appointing authority.

Agenda Item 10

After interchanges of thoughts between Leicestershire LAF members via our googlegroup we have agreed the following

LLAF recommendations for funding access and protection of the countryside

Current support for hill farmers in particular, to maintain gates, stiles and other infrastructure on access points to the countryside should be continued after we leave the EU

Beyond this we would like to see targeted support for permissive access under Stewardship/HLS schemes. By targeted we mean that it should only be on offer where there is a demonstrable public benefit from the access being offered with priority being given to missing links. Further we feel that such agreements should be better policed than has been the case in the past

From the permissive access audits in Leicestershire there is been evidence that a number of routes (where payment has been provided) have not been adequately maintained nor properly signposted by the landowner. This has also apparently been the case in the neighbouring counties of Rutland, Lincolnshire and Northamptonshire. This has not been acted upon due to a lack of inspections and with Natural England likely to have even fewer staff in the future, it is unlikely that this will improve. In the past a number of routes were also provided which had no real value to the public and only benefitted the farmers. This was a complete waste the taxpayers money.

We certainly need to cover the missing links in the network, and take any opportunity to upgrade to higher rights creating safer off-road routes to link PRoW and routes to locations of interest. Paying for permissive access is the right thing to do, however it is important payment is made for routes that are needed and wanted by the public and that are then properly maintained by the farmer. We would also propose that any future HLS permissive access type of funding should also be directed towards smaller privately owned farms and not large corporate or institutional organisations. Bodies like the National Trust, Wildlife Trusts, Woodland Trust or RSPB have other funding sources they could use to create accessible routes on their land.

We think that it would be good for LAFs to sign up to a letter to this effect to the Minister responsible, but getting a number of LAFs to agree a form of words usually becomes tricky. There are suggestions of starting a petition but again it is agreeing an actual form of words which is the challenge.

Here in Leicestershire we have been promoting retention of HLSS permissive access for some time. Parish Council precepts are not capped so parishes could support local routes where higher authorities have no funds and they feel local routes are of real value.

Trevor continues to identify issues that could become lost ways projects. Geoff suggested contacting the Shropshire Mines trust to identify potential Lost Ways in the Snailbeach area.

Volunteering 4.

- a. Central Shropshire Maintenance Officer (DH) the P3 groups have been very busy in Central Shropshire, in particular the Shrewsbury Ramblers P3 group who have been carrying out three sessions each month (a lot out of area). Condover P3 have recently carried out a lot of maintenance around the Dorrington area.
- b. P3 (HB) P3 groups across the county have carried out over 7621 hours of maintenance between April and December 2016. New groups have recently been started in Pulvebatch, Cockshutt, and Marton. There are now 71 P3 groups across Shropshire. New groups will potentially be set up in Sellatyn and

Church Stretton P3 group now have a new coordinator, which means they will continue with tasks next

Helen will be asking for the running cost grant requests in February so they can be processed in April. 56 people attended the ROW training course in November, funded by the Meres and Mosses LPS. The training was held at Whixall and consisted of presentations on ROW law and practical maintenance training. There will also be a brush cutter course before March 2017.

- c. Walking for Health (MD) The next Volunteer Walk Leader Training Courses will be held on: Fri 03rd Feb 2017 at the Shirehall in Shrewsbury – contact mick.dunn@shropshire.gov.uk Thu 02 Mar 2017 at Craven Arms – contact helen.dalbert@shropshire.gov.uk
- Walkers are Welcome Shrewsbury (JN) Unfortunately, the bid for Shrewsbury to become a Walkers are Welcome town failed. John hosted a representative from the WaW national committee but it was deemed that Shrewsbury was too large to become a WaW town. John with the help of Bob and Naomi are investigating the possibility of a cluster of smaller villages (Bayston Hill, Uffington, Pontesbury etc) forming a WaW cluster around Shrewsbury.
- **6. Shropshire Way Circular Route (JN)** The Shropshire Way main route has now been established in principle and a logo for way marking has been agreed. A funding application has been submitted to the RA Holidays trust to assist with funding to waymark and promote the route.

Volunteers will be used to help way mark the main route and carry out repairs and maintenance starting in the South.

The need to keep route changes to a minimum was reiterated. This is because the main route needs to simplify the Shropshire Way network rather than complicate things further.

7. Outdoor Partnerships Update (CF)

- a. Shropshire Great Outdoors Membership Scheme We have launched a new membership scheme in a bid to secure the future of the Shropshire Council managed Country Parks and Heritage Sites, and to help maintain ROWs above the statutory requirements. The scheme costs £3 a month (£36 a year). More details and how to join can be found at http://www.shropshiresgreatoutdoors.co.uk/join/. The new scheme has been devised to help address the threat to funding for Parks and Sites in particular and to secure these assets within the Council. Promotion of the scheme through partner organisations and networks would be appreciated.
- b. **Shropshire's Great Outdoors Strategy Board** it is being proposed that the Local Access Forum is restructured to make Outdoor Recreation in Shropshire:
 - More financially independent and resilient
 - More strategically important across a range of sectors
 - More action driven

The priorities for the next two years would be:

- Delivery of the Enterprise Plan- Business Planning, fundraising and income generation, including the development of a charitable organisation and promoting of the contracting team
- Development of the Countryside Access Strategy 2018-2028
- Promotion and marketing
- Increasing awareness of the benefits of outdoor recreation for health, the local economy and the environment
- Influencing and advising other departments, organisations and local and national policy
- Community engagement and volunteering

The Strategy Board would take on the role of the Local Access Forum as well as other duties and this would be reflected in a new Constitution.

There was some concern about the development of a group with a wider remit might distract from the Rights of Way focus of the Local Access Forum. CF reinforced the point that for the development of the Rights of Way network to be taken more seriously in the future, it needed to be perceived as more relevant to other agendas, such as the Local Enterprise Partnership and Health and Wellbeing Board. The development of the Board is necessary to integrate those who can influence these agendas.

- **c. Countryside Access Strategy 2008-2018 Review –** a review of the countryside strategy will be held in 2017. The aims are:
 - Countryside Access- 'Ensure that the access network meets the needs of Shropshire residents and visitors whilst recognising the special qualities of the landscape'
 - Making Local Journeys- 'increase peoples' use of the Rights of Way network for local journeys to support a sustainable transport network'

Feedback focusing on the 3 priorities identified by members:

Promoted routes:

Shropshire Way Clare Fildes

Public survey completed. 329 responses. 89% agreed main route should be developed. Appears that people were not entirely clear and thought, incorrectly that the plan is to start from fresh with an entirely new route. Most comments mentioned wish to showcase Shropshire across route. Figure of 8 route received most support as promoted main route, so has gone ahead as proposal by Shropshire Way Association (SWA). Details will be confirmed in due course.

Issues raised by members at meeting:

- Concern about lack of resources and time takes to re-waymark routes, and confusion this may cause.
 CF reported SWA has taken the mantle to ensure the old WM are taken down and the new ones replaced as timely as possible with P3 help. SW is on the electronic version of the OS mapping system- this route will not be wrong, nor will paper maps and the main linear route will be marked with new markers on the ground.
- 'Has OS got the capacity to recognise and differentiate between the old and new routes?' CF- no. We will need to decide whether OS should have the one main route or the SW network.
- Need for companion leaflet suggested to help inform tourists to the area about the route and changes.

SL had raised questions about routes that may get lost under the Deregulations Act 2015. Over 5600 km of paths in total. Presentation given by SB – (sent out with meeting notes) and Q&A session.

SB confirmed that the Formal application register is available on the Shropshire Council website under ROW which details where there are already claims for routes.

Concerns raised by Forum - how realistic is it for her team to process and reinstate all these routes? All agree it is not possible with the limited staff and resources. SL – could volunteers assist with the admin? SB – do have some volunteers from RA and horse riders.

MB – are FP's at risk of becoming bridleways and therefore used by bicycles? SB -to have FP's upgraded to Bridleways would need historical /user evidence to support this. FP's can be used by cyclists, but only with the landowner's permission; Long Mynd given as an example.

SL- ORPA's (Other Routes with Public Access) SB explained that in Shropshire these were mainly recorded as Unclassified County roads. There is a layer for County roads on SGO and Council websites. Highways are ultimately responsible for these. CF- wants to put an agreement together to work with Highways for our maintenance team to maintain the unsurfaced routes, with the transfer of funds for this, as feel our staff have the expertise to best achieve this.

Shropshire's Great Outdoors Membership scheme (Clare Fildes):

CF- SGO membership scheme is about to be launched. £3 a month. For people who would like to support the work we do with the Parks and sites and ROW outside of the statutory. Plan to set up a charitable organisation. Membership benefits – one of these is free car parking. Charges to be set up at sites that do not already have this in place.

CF- Bringing in funding is a major priority. The income from this is ring fenced for our service.

CE- Who and how will it be decided how the monies generated will be

spent and how are the priorities to be set? The priorities for the funding could be set by a restructured LAF. There are discussions underway for the LAF to become the Shropshire's Great Outdoors Strategy Board to make it a more strategic body and link better with other agendas such as health and the economy. The exact responsibilities of the new Board have yet to be agreed. CE- idea of feeding back periodically what the membership funding has funded over a period of time, demonstrating what has been achieved.

Promotion of Walking Festivals (Glyn Roberts):

BC walking festival in 17th year – would like help to promote the festivals for benefit of local walkers, visitors, local community - but does not want to encroach on the toes of other festivals in the county. Local businesses support some Walking Festivals, but BC does not have this opportunity as businesses already provide great support to plenty of other causes and the many other festivals in the local area.

NMcD- Council in process of applying to Defa for funding (£50,000) for a promotion and marketing programme for tourism, (walking festivals are within this theme). Bid due in this month and will run from next year if successful. NMcD explained the process. This will help us to showcase walking in general in Shropshire. GR since extending the duration of the WF, numbers have increase and thus the benefits to local businesses, but evidencing how this has resulted in an increase in jobs would be difficult to show.

Forum asked question: could WAW help coordinate the festivals? Shropshire Great Outdoors site – could there be a section on WF's?

NMcD reports met recently with VS, and they are trying to keep the momentum built up over the last few years with Shropshire Hills WAW, but finding this difficult. SGO – looking at developing a business network. Useful mechanism as could be linked up with this potentially to help support the WF's etc?

NMcD- there are lots of ways that we can link networks in to help support WF's etc. – websites / Facebook etc. need to be linked in some way. At present each is limited as they are reliant on local festivals sending items to all the websites. Recommended SGO / Virtual Shropshire and Shropshire Hills Tourism are the primary ones to promote WF through. NMcD would like to see people come together from all the walking

festivals across the county to help provide mutual support.

CF- to speak to Mick Dunn about arranging a meeting with all those involved in WF's in the county to discuss issues and ideas. Idea suggested of having a Shropshire Walking Festival, as a whole with these taking place on different dates across the county?

Independence of becoming a conservation board is in process- it has been put forward and they have been told that the outcome will be positive but they are awaiting ratification. Discussions to take place with Defra as to how this will work. Case to be put to Defra at the end of November, then if positive response from Defra the legal process will then commence. N.B since the meeting NMcD reported T&W approved AONB Conservation Board unanimously on 13.10.16 and case was to go to SC cabinet the following week.

AOB & reminder of next forum meeting date:

SB – Annual ploughing and cropping campaign –persistent offenders and landowners/occupiers who have had reports of cropping or ploughing within the last year receive a letter. Results of the 2016 campaign revealed that the majority were in the North of the county. Out of over 120 initial letters, 89 were in the north of the county and following additional correspondence this resulted in 63 landowners complying and reinstating their Public Rights of Way. Overall this has been a successful campaign. Land ownership information found to not be wholly up to date- working on this for next year-so hoping to build on this success next year. The landowner guidance leaflet has been sent out with these letters to help reinforce landowner's responsibilities. To report a complaint- do as normal either via the outdoor rec generic email address or via the Council's website.

GR- 'Countryfile - Children in Need' walk 2 hour walk this Sunday in BC-20 people came with wide age range - £115 raised through donations. Can we promote this as a county next year?
