⁵ "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

Corporate tenancies Any tenancy where (to your knowledge)— None (a) the landlord is the Council; and (b) the tenant is a body in which you or your partner has a beneficial interest. **Securities** none - (24/10/12) Any beneficial interest in securities of a body where---(a) that body (to your knowledge) has a place of business or land in the area of the Council: and (b) either-(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
