Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period ³ in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.	
Contracts Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest ⁴) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.	MONE
Land Any beneficial interest in land ⁵ which is within the area of the Council.	NONE
Any licence (alone or jointly with others) to occupy land in the area of the Council for month or longer.	NONE

NOTES ON SENSITIVE INTERESTS

An interest is sensitive if its nature is such that you, and your Monitoring Officer, consider that its disclosure could lead to you, or a person connected with you, being subject to violence or intimidation

The nature of your sensitive interest will not appear in the published register of interests but it may be recorded that you have a sensitive interest.
