Continuing in a general south easterly direction to a stile at point B on the Order Map (SO 7185 8751); a total distance of approximately 91 metres **onto a line** from point A on the Order Map (SO 7179 8758) running in a general north easterly direction along a surfaced track, turning in a general south easterly direction through a gate then running on a natural surface in a south easterly then SSE direction to a gate at point B on the Order Map (SO 7185 8751); a total distance of approximately 124 metres with a width of 2 metres throughout its length.
