

# Notice of landowner deposit under section 31(6) of the Highways Act 1980 and 15A(1) of the Commons Act 2006

## Shropshire Council

An application to deposit a landowner statement under section 31(6) of the Highways Act 1980 and deposit a statement under section 15A(1) of the Commons Act 2006 has been made in relation to the land described below and shown outlined red and blue on the accompanying maps.

Deposits made under section 31(6) of the Highways Act 1980 may prevent deemed dedication of public rights of way over such land under section 31(1) of that Act. Deposits made under section 15A of the Commons Act 2006 may affect the ability to register such land as a town or village green under section 15 of that Act. 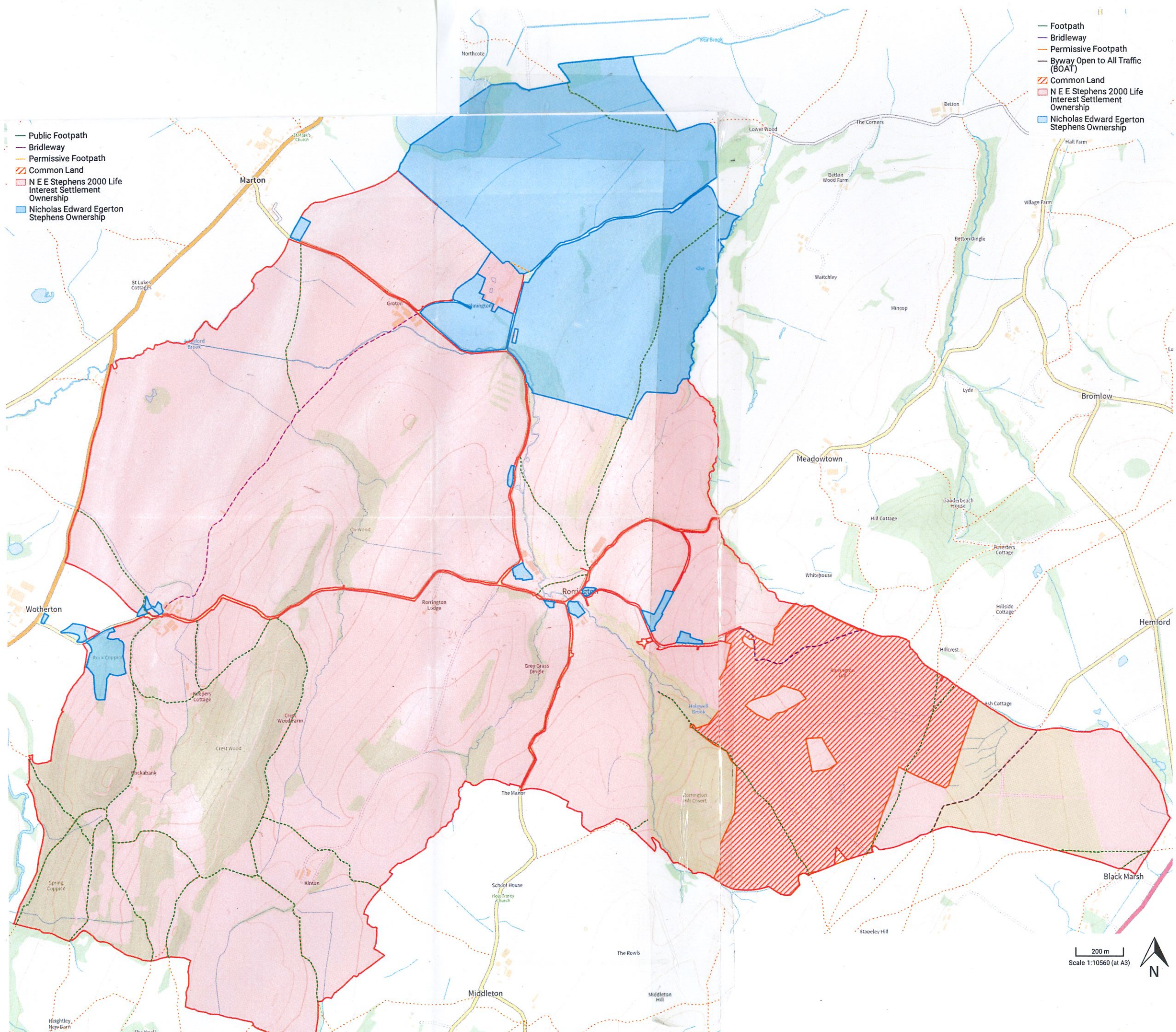
