**divert** approximately 675 metres of Bridleway 10 (part) from the County Road at grid reference SO 6818 9197, running in a general north westerly direction to grid reference SO 6755 9211 **onto a line** of approximately 496 metres leaving the County Road at grid reference SO 6791 9243 running in a general south westerly direction to re-join the Definitive Line of BW 10 at grid reference SO 6755 9211.
