

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)**

**1. THE SHROPSHIRE COUNCIL (FOOTPATH 8Y (PART) TOWN OF
SHREWSBURY) PUBLIC PATH DIVERSION ORDER 2023.**

The above order was made on 6th April 2023. The effect of the order will be to divert

The full width of FP 8Y to be extinguished leaving Welshpool Road at point A on the Order Map at grid reference SJ 4521 1342 running in a general NNE direction to point B on the Order Map at grid reference SJ 4525 1350. A total distance of 94 metres **onto a line** leaving Welshpool Road at point C on the Order Map at grid reference SJ 4529 1339 running in a general north easterly direction on a surfaced path, alongside the estate road, crossing the estate road then in a general NNW direction on a surfaced path along the southern side of the pond to rejoin the Definitive line of FP 8Y at point B on the Order Map at grid reference SJ 4525 1350. An approximate total distance of 150 metres with a width of 2 metres throughout its length.
