Summary

Three organisations in total have submitted bids requesting funding from both the Community Chest and also the Larger Grant Scheme.

Recommendations

- A. That the Committee consider the applications received in light of Officers' recommendations for the Community Chest and the Larger Grant Scheme
- B. That the Committee confirms grant approvals or rejections and any terms and conditions for each application considered.
- C. That all Committee members help publicise the availability of LJC funding and advise the Community Regeneration Officer, Vicky Turner of any groups with potential projects.

Report

Allocation of resources

1. Bridgnorth, Worfield, Alveley and Claverley Local Joint Committee have a devolved budget of £71,000 which the Committee has allocated as follows:-

Community Chest - £10,000 providing small grants up to £500 (subject to the criteria agreed by the Committee and which are referred to later within this report).

- Larger Grant Scheme £61,000 providing funding for projects over £500 with grant applications not normally exceeding £5000 (subject to the criteria that are referred to within this report).
- 2. The closing date for Round 2 funding applications was 11 June 2010 and within the relevant period three applications were received. Two applications for the Community Chest in the sum of £800 and one from the Larger Grant Scheme totalling £4842.

3. This is the second round of applications for the financial year 2010/2011.

Criteria for Consideration of Applications

4. As Members are aware an assessment pro forma has been developed for use in the initial consideration of these applications by Officers. All of the projects have therefore been assessed against the following criteria:

Eligibility

- Projects will be delivered in the eligible area
- Project meets approved financial/grant criteria

Assessment

- In the local area
- Percentage match funding
- One application per applicant per year
- Is for £500 or less (Community Chest) or £5000 or less (Larger Grant Scheme).
- Is not for profit
- Denominates need
- Delivers local community benefit
- Assures that application can deliver project
- Demonstrates sustainability
- Demonstrates no adverse environmental impact
- Provides benefit to wider community in the Committee area.
- That applications from Town and Parish Councils with a precept below £5000 be considered only in exceptional circumstances and that funding applications from Town and Parish Councils with a precept above £5000 should not be considered.

Applications, summaries and officer recommendations

<u>Community chest</u>

<u>C5 Bridgnorth & District Camera Club</u>

Project Cost £ 349 Amount Applied for £300

Previous Applications to LJC - 2009/10 £428 towards display boards

This application is for studio lighting. Since their successful grant application last year the membership of the group has grown by 30%, and in respect of which their Chair states "I'm sure the funds you awarded last year, helped enormously to promote the club".

C6 Alveley Band – 20th Year Celebration

Project Cost £2,690 Amount Applied for £500

Previous Applications to LJC - None

Alveley Band is celebrating its 20th year with a series of concerts. To mark this occasion they have new music, additional conductor costs and would like new uniform, and have asked the LJC to assist them.

Officer Recommendation: Fully Fund £500

<u>Larger Grant Scheme</u>
4 Bridgnorth Bowling Club

Project Cost £6,457 Amount Applied for £4,842

Previous Applications to LJC - None

The grant application is towards the purchase of a new mower for daily use to keep the green at a match playing standard. The application was based on the most expensive of three quotes.

Officer Recommendation: Fund £3,942 which is 75% of the lowest quote Reason for not fully funding: Still some use in existing mower and the majority of members are from Bridgnorth.

5. Members are referred the Appendix which sets out the applications to date, the grants awarded and also the remaining budget for the financial year 2010/2011.

Promotion of Grants

6. This round of grant applications is particularly small. In part this reflects a number of applications who have not managed to meet the deadline and will come forward for the next meeting. However, it's really important that the committee makes best use of funding to benefit groups in the area. Committee members are therefore asked to support Vicky Turner, Community Regeneration Officer, by alerting her to potential projects in their area. These could be small, new community groups looking for help with set up costs, or more well established groups wanting to develop their services.
