28. DISCLOSABLE PECUNIARY INTERESTS

29. NOTES OF PREVIOUS MEETING

RESOLVED:

30. FEEDBACK FROM FUNDED PROJECTS

30.1 1st Brown Clee Guides

Helen Allen and three Guides from 1st Brown Clee Guides were in attendance. They had received a grant of just under £500 from this LJC in order to purchase sports equipment. Equipment was procured from local companies, and the leftover money would be used to fund sporting activity days. Recent funding activity days had included an activity day at the Old Vicarage Activity Centre, and a Hip Hop dance workshop.

The Guides were currently working towards their Hostess badge, and, as part of this, provided tea/coffee/cake prior to the meeting.

30.2 Chelmarsh Parish Council

Mrs Yeomans, Clerk to Chelmarsh Parish Council, was in attendance. She explained that the playing field had been well used up until the time of the closure of the local village school. Following an inspection in 2010 by RoSPA, the equipment was deemed to be outdated and in need of replacement/repair. Following deliberations, and as it would cost too much money to repair, the Parish Council decided to remove the equipment. All residents were then consulted to ascertain:

- Whether or not they would like new equipment purchased, and, if so, what;
- The age range of children in the household and age range of any visiting relations; and
- How many times it was envisaged that the equipment would be used by residents and visitors.

Over 50% responded, with the majority in favour of providing swings, climbing frame and a slide.

Estimates were obtained, and using money from the Playbuilder Scheme and this LJC, wooden structures (cradle swings, slide and climbing frame) were purchased and erected. The equipment had subsequently been well used.

In conclusion, she offered assistance to any other Parish Council that was considering the replacement of play equipment.

31. PLACE PLANS – THE NEW LOCALISED APPROACH TO PLANNING

Jake Berriman, Internal Consultant: Strategic Delivery, Shropshire Council, was in attendance and gave a presentation on the Place Plan Review Process (a copy of which would be appended to the signed minutes), and answered questions from the floor. With regard to the Brown Clee and Highley Local Joint Committee, Highley was covered in the Highley Place Plan, and Brown Clee Ward fell within the remit of the Bridgnorth Place Plan.

He explained that Place Plans would list all of the priorities, needs and aspirations on a place by place basis for each of Shropshire's communities, building on the community's requirements identified in individual Town and Parish Plans and local evidence of infrastructure requirements from infrastructure and service providers. As such, Place Plans sought to bring together "bottom-up" priorities, originating from community aspirations with "top down" schemes and actions, originating from large organisations such as Shropshire Council; and gave a voice to all community-led plans (Parish Plans and Neighbourhood Plans) as well as the Local Plan. Place Plans would inform Shropshire Council's service delivery plans, asset strategy and where monies should be targeted.

Best practice guidance was awaited to ensure there was no "double-dipping" with developers paying twice for the same item of infrastructure.

CIL monies could not be used to remedy existing or past problems, or be used to remedy what other bodies should do, but should accommodate the strain of new development. Any development in the future would have to bring financial benefit to a community. No new development should impact on existing drainage.

If an area has chosen to be designated as 'countryside' rather than a hub or cluster, then development would be strictly controlled and only allowed in exceptional circumstances. Consequently, if a parish choose not to have any growth, then it would not benefit from any monies.

<u>Clusters</u> – Any monies gained would be pooled and it would be up to the individual parishes to decide where the money should be spent, either within the cluster or elsewhere within the Bridgnorth Place Plan area. Monies gained from development in an area not within a Parish Plan area would be pooled and spent by Shropshire Council.
