## **Summary**

To make appointments to committees, groups and outside bodies where urgent appointments are required, and to agree a process for the consideration of appointments to the remaining committees, groups and outside bodies.

### Recommendation

- A To agree urgent appointments to the committees, groups and outside bodies set out in appendix 1 to this report.
- B To agree that a small working group comprising Group Leaders be established with delegated powers to appoint to the committees and groups listed in appendix 2 (to follow) and outside bodies listed in appendix 3 (to follow), and that any bodies where agreement cannot be reached by the Group be referred back to Council for decision.
- C That the Chief Executive, in consultation with appropriate Group Leaders, be authorised to agree any other appointment that may be necessary as a matter of urgency.

#### **REPORT**

### **Background**

- 1. Shropshire Council is asked to make appointments to committees, groups and to over 200 outside bodies. The outside bodies range from national, regional and county organisations down to local charitable bodies. Under the Constitution, appointments to outside bodies are the responsibility of the Council.
- 2. Some appointments need to be made urgently as meetings are scheduled for June and early July. National and regional Local Government Associations also need to know representation in order to set political balance.

## **Proposals**

- 3. Those committees, groups and outside bodies where urgent appointments are required are set out in appendix 1 to this report. Council are asked to agree appointments to these bodies.
- 4. It is then recommended that the remaining appointments are considered by a working group with delegated powers comprising of Group Leaders and that any areas where agreement cannot be reached by the Group be referred back to Council for decision. The indicative list of committees, groups and outside bodies requiring representation for the Working Group to consider is set out in appendix 2.
- 5. If any further appointments arise of an urgent nature before the meeting of the working group, it is proposed that the Chief Executive, in consultation with Group Leaders, be authorised to agree any appointments required as a matter of urgency.
