Learning Disability Strategy: Action Plan for Implementation

This action plan has been developed in response to the Shropshire Learning Disability Strategy 2010-2013. Key priorities for action, are set out as they are in the strategy, against the areas indicated in Valuing People Now.

This action plan is in development. The areas that have already been completed include suggestions made during the consultation process on how the priorities can be achieved and the previous Learning Disability Partnership Board annual work plan which has now been merged into this overall action plan. Areas which are not yet complete will be developed through contributions made by the membership of the Partnership Board at themed away days scheduled for the forthcoming year. This approach ensures that people with learning disabilities, their advocates and family carers will be contributing and involved in delivering this strategy over the next three years.
