Health and Wellbeing Stakeholder Event – Strategy to Implementation and regular stakeholder engagement

# 1. Summary

- 1.1 On 31 January 2013, the Health and Wellbeing Board hosted a joint stakeholder event, Health and Wellbeing Strategy to Implementation. The event was very well attended (oversubscribed) with approximately 150 stakeholders present; including representatives from the voluntary community sector, patient groups, service providers (managers), service users, commissioners and NHS professionals.
- 1.2 The event began with lunch and 'clinics' displaying telehealth/assistive technology and the opportunity to sign up to the online Stakeholder Alliance. Following this there were were presentations that highlighted the purpose of the HWBB and the day, the HWB Strategy and journey so far, and how we plan to engage with our stakeholders in the future.
- 1.3 The partnership also produced a 'You Said, We Did' document which demonstrates how the strategy has been updated/ changed based on the consultation and is very much a working document with wider input from partners.
- 1.4 Stakeholders split into 8 groups working on the HWBB 8 Priority areas. The groups were asked to develop ideas around (1) what communities do well for themselves now, that the HWBB could further support (2) what is the current situation and what services are available now (3) if we are not achieving 'good' now, what would 'good' look like, and (4) what do we need to do together to achieve 'good'. The information at the event is currently being collated and will be used by the partnership (including senior managers from Shropshire Council and the CCG) to develop each Health and wellbeing priority area.
- 1.5 As also reported in the Health and Wellbeing Executive Report to the Board, the information gathered at the event will be used to feed into the action planning process by the Executive. This will allow the Executive to take forward priorities with good input from our stakeholders.
- 1.6 Building on our engagement so far, and led by the CCG, we are developing Community Focus Groups. 'Trainer the Trainer' type sessions have been scheduled for the first week of March. It is anticipated that we can build on our understanding of our communities and their needs around health and wellbeing by asking community leaders to run focus groups in their community or community of interest and report back to the CCG and the Board (partnership).

1.7 Going forward we also propose that the Stakeholder Alliance have regular input into the Health and Wellbeing Board priorities by a regular report to the Board. The Alliance would link into the Outcome theme for each Board meeting. The Stakeholder Alliance will be asked appropriate questions in order to provide responses and up to date information about the outcome areas.

#### 1.8 Feedback from the HWB Event:

- Some groups have been extremely pleased that they can see how the Strategy was updated/ changed as a result of the information and feedback they provided.
- Attendees were generally very happy with the mix of stakeholders invited and liked the prospect of commenting on the online stakeholder alliance before the event.

1. Discuss regular input from our stakeholders and approve receiving regular updates to the Board through the Stakeholder Alliance

### 5. Background

Consultation on our Outcomes and Priorities began in 2011. The Health and Wellbeing Strategy development was based on Stakeholder input and the Joint Strategic Needs Assessment.

The first draft of the Strategy was published for consultation in the summer of 2012. The final draft strategy was approved by the Health and Wellbeing Board in December 2012, however as the Board is still in Shadow form it must also be approved by the CCG Board and by Cabinet.

The Stakeholder Alliance has been developing over 18 months and the on-line network since the summer of 2012. The on-line network proved invaluable to developing the material and discussions for the 31<sup>st</sup> January Stakeholder Event and this is indicated in the feedback from the eventThe on-line network is a 'one shop stop' and holds relevant information for the Health and Wellbeing Board, the HWB Strategy, a Commissioners Guide to the Voluntary Sector, information and links to the Joint Strategic Needs Assessment and monthly newsletters. The Network has terms of reference for all who joining the network to ensure that members understand their role and responsibility as a member of the Alliance.
