**2012/13 FINANCE REPORT:

Summary

This report considers the devolved funding allocated to the North East Shrewsbury Local Joint Committee (LJC) for the period 1st April 2012 up until 31st March 2013.

A total of £25,609 has been devolved to the Committee to fund projects in the local community served by the LJC for the 2012/13 year.

Prior to each LJC, a planning meeting takes place to discuss applications for funding and agree recommendations.

Six applications have been received for this reporting period and are put forward to the LJC to be held on 3rd July 2012.

Recommendations

- That the LJC considers the applications received, and awards funding to those organisations and their projects that benefit the North East Shrewsbury area.

Report**Background**

North East Shrewsbury LJC is responsible for the award and expenditure of a devolved budget. The amount available to the LJC in 2012/13 has reduced as a result of Shropshire Council budget decisions, and a review of locality working in Shropshire. This amount has however been supplemented by the transfer of funding previously available for Community arts projects in to the LJC budgets, and under spend carried forward from 2011/12.

The total amount therefore available to North East Shrewsbury LJC is calculated as follows:

Budget based on this electorate following 50% budget reduction	£18,500
Minus 30% top slice of funding for Shrewsbury wide allocation	£12,950
Plus apportioned allocation of community arts budget	£ 1,534
Plus carry forward of under spend	£11,125
Total budget for 2012/13	£25,609
