Decision Report for Oswestry Local Joint Committee

Summary

This report considers the applications made to the Community Chest received by the 10 September and recommends increasing the Community Chest budget. This report also provides an update on the 20010/2011 budget.

Recommendations

A - It is recommended that the Oswestry Local Joint Committee allocate funding to those organisations and their projects as set out in Appendix A to this report .

Background

1. At the Implementation Executive on the 19 March 2009 it was determined that there will be 28 Local Joint Committee's for the new Shropshire Council. A devolved budget of £54,000 has been allocated to the Oswestry Local Joint Committee based on its electorate.
2. The Constitution governing Local Joint Committee's states:
 - Each Local Joint Committee (LJC) has a delegated budget which will be confirmed on an annual basis.
 - The LJC must use the standard guidelines and application form when granting funding to third parties.
 - The LJC budgets will be subject to Shropshire Council's audit procedures.

4. The Oswestry LJC has an available budget of £34,752.12 for the remainder of this financial year.

Community Chest - Round 3

5. The closing date for applications to be considered at the 7 October LJC meeting was the 10 September 2010. By the closing date four applications had been received, totalling £6,695.84, all of which meet the key eligibility criteria. The total amount being recommended for funding is £6,695.84. The Community Chest Budget of £10,000 will cover all requests for funding. Those recommended for funding are shown at Appendix A.
6. The recommendations have been made on an assessment of each application against the rules of the Local Joint Committee and the Community Chest rules as set out in this report. It must be noted that, the Committee has the authority to fund any eligible project considered on a case by case basis.
7. The deadline for applications to be received for the second round of bids which will be considered by the Committee on the 27 January 2011 is Friday 7 January 2011.
