**1. ANNUAL ELECTION OF CHAIRMAN**

The Committee also noted the 'Comments, Questions and Suggestions' Action Sheet which was circulated at the meeting.

#### 6. **PACT MEETING**

PC Karena Evans of the Local Police Team gave a verbal update on local policing issues in both the rural and town areas of Whitchurch.

The following issues were highlighted:

- 'Party in the Park' on 1 June had been a great success with little trouble.
- The excellent work of the Community Alcohol Partnership Group was highlighted and continued.
- There was some criticism of the traffic lights operating at the junction opposite the police station in Whitchurch where vehicles often jumped red lights. This was dangerous and it was requested that the timing of the lights be looked at again before there was a serious accident.
- Problems were also reported about vehicles turning left from Brownlow Street into Talbot Street. It was requested that the white line at the end of Talbot Street be moved up to enable larger vehicles to turn the corner.

In response to a question about how the reorganisation of the local police would impact on the north of the county and especially the Whitchurch and Prees area, PC Evans could not comment except to say that there would be no less police presence.

No new issues were raised by local residents present at the meeting.

Mr Gilling, Area Co-ordinator, Neighbourhood Watch updated the meeting on local developments and how to go about setting up a local Neighbourhood Watch scheme in your area.

Fire Officer, Pete Furber from North Shropshire Fire and Rescue Service, gave an update on local issues and was pleased to announce that there were no significant trends to be concerned about within the local area.

However, it was noted that 4 'on-call' fire stations had recently been identified to possibly close under the Fire Service's latest re-structure proposals. Prees's station was amongst those highlighted and would shortly be undergoing an impact assessment. It was very much hoped that the station would be able to continue and everything was being done as far as possible to support staff and the station.

## **7. COMMISSIONING SERVICES FOR THE NORTH OF THE COUNTY**

George Candler, Director of Commissioning, gave a brief presentation about what commissioning was and how Shropshire Council was working with partners on this in the northern part of the county.

First, he outlined what Shropshire Council was trying to achieve;

- Meeting local demand more efficiently and reducing future demand
- Providing customer value
- Engaged and resilient communities that own the challenges and solutions
- Supporting employment and economic growth

George Candler then went on to explain what had been happening recently;

- a) Looking at the needs of the area
- b) Talking to the community
- c) Going into detail around three key areas;
  - \*Public realm
  - \*Unemployment
  - \*Health/Social Care

The following was very briefly what was going on at the moment;

- 3 new ways of working (prototypes) were being tested
- What had been discovered was being fed back to key senior partners very shortly
- More areas were being considered (based on need)

Pleasingly the new approach was already providing dividends and it was planned to roll out this new way of working very shortly.

The Chairman thanked Mr Candler for his full and frank presentation which was very informative.

Dianne Dorrell, Support Officer from Shropshire Association of Local Councils (SALC) gave a short presentation on how to become a parish councillor if anyone was interested.

## **10 TOWN AND PARISH COUNCIL UPDATE**

### Prees Parish Council, Cllr Joe Whelan

There was 1 vacancy left on Prees Parish Council - if anyone was interested in applying, all applications would be most welcome.

Progression of plans for the new Doctors Surgery at Prees continued, with the support of a local firm.

The Parish Council's website was currently being overhauled and redesigned to make it more user friendly and try and engage more residents.

Finally it was stated that the Parish Council were aware of the proposed budget cuts within the Fire Service and fully supported the retention of the Prees on-call fire station and the local fire service.

### **Whitchurch Town Council, Cllr Peter Lea**

Tenders were going out for Phase 1 of the redevelopment of Whitchurch Civic Centre and works were due to start shortly.

The Civic office was due to close on 12 August 2013 and would probably be re-locating to the Heritage Centre, though this was yet to be confirmed.

Phase 1 Refurbishment was due to be complete by the second week in February 2014.

- vii. Whitchurch Town Council – Consultant Fees for Phase 2 of the Civic Centre Refurbishment £2,000

Total awarded at the meeting = £ 8,892.50.
