commitment to both the Church and the village and are respected and loved by many." Tragically, Mr Roberts passed away very suddenly at just 48 years of age in 2018, leaving a young widow behind him. As Pauline Smith, owner of *The Royal Oak* writes<sup>2</sup>: "We have found them to be very quiet and extremely pleasant but most of all very honest and trustworthy... It would be quite heartless for this wonderful little family to be left homeless...this lady has had more than enough tragedy..." Immediate neighbours Mr & Mrs Turner write: "We have enjoyed having them in the village... To prove her kindness, whist on Lockdown Sharon [Roberts] kindly delivered food and essentials. We would really like to see them have a permanent home in Alverley as in our eyes they are now part of our community." The Parish Council also support this application because the family have shown themselves to be good neighbours in the decade they have been living in the village. Clearly, the proposal meets CS12 as a "small exception site in accordance with Policy CS5, as a strong local connection is demonstrated." CS 5 is met because this proposal provides "accommodation to meet a local need in accordance with CS12."

The Officer's Report fails to refer to the adjacent site – also in the Green Belt – where permission was granted for an affordable dwelling (18/03970/FUL) on the grounds of a *"strong local connection and personal circumstances"* both of which apply in Mrs Roberts' case with even greater force. Moreover, as the adjacent site was found to be in a sustainable location, so too must this; indeed both formed part of the same landholding originally.

There are 3 children under 5 for whom the application site is their only home, the eldest starts nursery in January and has her name down for Alverley Primary school. Paragraph 16 of *Planning Policy for Traveller Sites* states: "**Subject to the best interests of the child**, personal circumstances and unmet need are unlikely to clearly outweigh harm to the Green Belt and any other harm so as to establish very special circumstances."

Those circumstances, together with the unmet need for 113 additional pitches (2020 *Gypsy and Traveller Accommodation Assessment*) and the family's personal circumstances, combine with Officer's conclusion<sup>3</sup> that there are no alternative pitches to accommodate this family to amount to the very special circumstances that justify planning permission in this case.
