Primary Care Networks

The committee agreed to look again at the then emerging primary care network.

Improved Better Care Fund

The committee had agreed to set up a task and finish group to consider the risk of the discontinuation of the Improved Better Care Fund. However the committee may wish to bear in the mind the frequency with which it has considered this item in its committee meetings.

Public Health Outcomes

The committee has twice considered the issue of the use of public health grant funding to deliver council services with a public health outcome. It initially agreed to set up a task and finish group to measure the impact of funding, but this did not take place.

Emergency out of hours dentistry

This was suggested in a work programme discussion at a committee meeting. However the minutes do not provide any additional information about the potential scope of this item.

Transport for outpatient services

The Communities Overview Committee has repeatedly scrutinised poor public, community and patient transport services in rural areas. That committee continues to scrutinise public and community transport services. The Clinical Commissioning have advised that the new patient transport service will begin on 1 October 2021.

Care home demands on primary care networks

This was suggested in a work programme discussion at a committee meeting. However the minutes do not provide any additional information about the potential scope of this item.

Joint Strategic Needs Assessment (JSNA) and Health and Wellbeing Strategy

The committee scrutinised the development of the JSNA and health and wellbeing strategy in early 2021 and was critical of the long delay in producing these two key strategic documents.

Health and Wellbeing Board commissioning subgroup

The committee wished to scrutinise in greater depth the council's health commissioning arrangements. It may wish to broaden this remit to include all commissioning arrangements in light of the emerging integrated care system.

Children and Young People's mental health services at Shropshire and Telford Hospitals Trust (SaTH)

A recent unannounced inspection of mental health inpatient services at SaTH rated those services at inadequate, forcing SaTH to cease all admissions. The committee may wish to look at the implications of this for provision of services to children and young people in Shropshire.
