Have undertaken an automatic traffic count and speed survey on Wrexham Road from 14 th to 20 th June. Based on the speed survey the visibility required is 56 metres whereas the visibility actually available is just over 96 metres.

Seven further representations have been received: three of objection and four in support. The representations reiterate points already made and raise no new issues, ie the main objections continue to relate to unsafe access provision and traffic problems whilst supporters emphasise the need for quality/varied housing stock in Whitchurch to support established/new businesses and consider the proposal offers highway improvements and will have little impact on Wrexham Road traffic.
