1. Apologies and Substitutions

Apologies were received from Shropshire Councillor Jon Tandy, Shropshire Councillor Jane Mackenzie, and Parish Council Chair Teresa Lewis.

4. Key Current Policing Issues – PACT (Partners and Communities Together)

4.1 PC David Harte introduced this item. He reported Bayston Hill was a low crime area. The current police priority was shed break ins and distraction burglary and police were currently working with the Community Enablement team at Shropshire Council on educating vulnerable residents on these matters.

4.2 PC Harte said he was aware of some issues of young people gathering outside the Christ Church and climbing on top of the roof and that this would be dealt with.

4.3 Residents were concerned about some graffiti in the area around the skate park.

5. Bayston Hill Jubilation

5.1 The Chairman deferred this item due to the responsible committee member sending her apologies.

6. Shared Counter proposal from Post Office

6.1 The Chairman opened up the meeting for discussion around the Post Offices proposal for a shared counter within the SPAR shop.

6.2 Residents raised concerns around lack of consultation from Post Office and a lack of responses from them where queries were raised. Residents also felt the new counter would be slower and less private which could cause some security concerns.

7. The Former Oakland School Site & Glebefield

Chris Edwards from Shropshire Council introduced this item with a short presentation regarding future development on both the former Oakland School site, owned by Shropshire Council, and the Glebefield owned by the Diocese of Lichfield.

7.1 Residents raised alarm at the amount of time the development has taken.

7.2 Some residents raised concerns that public open green space would be lost out of the centre of the village

7.3 There was also concern raised that more discussions need to take place about this proposal and the type of development it may become.
