ACTION

1. Welcome, introductions and apologies for absence

- 1.1** Vince welcomed everyone to the meeting and explained that the meeting was called with the intention to share an update on the youth Commissioning work for Oswestry. The time was chosen to offer parents a chance to attend prior to collecting their children from school.

Apologies were received from Paul Milner.

2. Declarations of Interest

- 2.1** No declarations were made.

3. Minutes of the last LJC Meeting

- 3.1** The minutes were agreed as an accurate record of the previous meeting.

4. Youth Locality Commissioning in Oswestry

- 4.1** Vince commenced with a thanks to Steve White for the work he has done around Oswestry's Youth Commissioning.

He then reminded the meeting of the steps previously taken, reminding the successful questionnaire returns. He expressed that the LJC hopes to have a wider youth offer for Oswestry than we have had before.

- 4.2** Vince then handed over to Steve to talk about the draft commissioning intentions.

Steve asked the attendees to review the recommendation report and list of draft list of intentions. This list is open for comment and once agreed will be posted on Shropshire Council Web page for consultation. The consultation will last for 6 weeks and will be done alongside face to face consultations with young people in Oswestry supported by Shropshire Youth Association (SYA) and Community Enablement Team.

SYA and Energise are in place as infrastructure Provider commissioned by Shropshire Council. They will support with the formation of new clubs, support the continued development of clubs, offer training and support with DBS checks and paperwork.

A question was posed of was the Oswestry Youth Council (OYC) consulted? Answer: they were not directly consulted as a body but members of the youth council were given chance to comment throughout the process as individuals.

A provider Event was held with potential service providers for Oswestry & District. This was well attended and valuable information was gained to aid the process. Information on what was discussed and shared was shared with the LJC attendees.

Vince, Keith and Steve have been meeting with individual providers who have shown an interest in providing youth services to meet the outcomes and needs in Oswestry. Any providers who have not met with them and want to are welcomed to contact and make arrangements.

The consultation document is draft but as soon as the final consultation document is completed and online Steve will promote this as widely as possible.

Keith shared his thanks to Vince and Steve for the work they have done.

Report recommendations will be taken forward as no challenges or amendments were shared.
