5. COMMUNITY SAFETY, FIRE SERVICE & HOUSING UPDATES

Police – Jane and Shelley spoke about recent crime figures, hi-lighting that there was a significant spike in thefts from outbuildings and farms across the West Midlands – mostly opportunist crimes – driving around, pretending to be lost doing a reccy of the area and risk assessing whether to come back or not.

Dorset and Hereford Police have adopted the Stop Thief scheme – issuing signs to anyone that has been burgled, and in Hereford there have been no repeat thefts.

West Midlands Crime Prevention Officer, can offer more specific advice on preventing these thefts.

Community Messaging Service

This has replaced the Dot Mailer alert system and can be accessed from the West Mercia Police homepage (click on messaging service) giving alerts and is another way of bring concerns to WMP

101 Service

Concern raised - people are calling, but the calls are not always answered – the police communications team are aware of these problems and work is being done to improve it.

6. DECISION NOTES OF THE MEETING HELD ON THE 23rd MARCH 2016 (REPORT A)

The minutes were agreed as an accurate record.

7. FUTURE OF LOCAL SERVICES

Gwilym Butler gave a summary of the results of the parish services survey that he and Madge Shingleton has undertaken over the summer

There were responses from 149 households

The general feeling was that approx. 2/3rds of the responses received were in favour of supporting the library service and also youth activities, but, that further information was needed about the leisure service.

Even people that don't use some of the services wanted to support keeping them.

The survey gave the opportunity to make comments on services and 70 comments were received and will be used in the future by the LJC committee.

8. 2L BUS SERVICE

Steve Todd updated on the bus service.

There is light at the end of the tunnel – talks are underway with Shropshire Council and another operator (early stages). Shropshire Council are also looking at other options and are considering a community transport bus to enhance the 2L service at key times.

There are no plans to scrap the 2L service – Shropshire Council currently pays £54k subsidy each year to retain the 2L route.

Diamond have recently been in front of the Traffic Commissioners (TC) on their inability to run a proper service – no decision has been made by the TC

Steve was thanked, for all the work that he does for local transport

9. UPDATE ON NEW PROPOSED CROSSING

Recognition was given to the hard work that Cleobury Parish Council have invested in this project, working with Shropshire Council to look at the best solutions for the current crossing and also the new one following the Co-op development.

Assurance is needed from Shropshire Council that the funding from the crossing does go towards the proposed new crossing and that following community consultation that the crossing is where it is needed and is the style that is needed.

10. YOUTH COMMISSIONING (REPORT B)

RECOMMENDATION:

That the decisions made by the LJC committee in conjunction with Cleobury Youth Partnership during the summer on grant allocations to:

St Marys Youth Project £1,000

South Shropshire Youth Forum £1,000

Cleobury Guiding £500

It is uncertain at this time if the LJC will receive funding for youth activities for 2017/18 – the LJC Committee will be update when a decision has been taken.

Madge Shingleton as Chair of the Cleobury Youth Partnership thanked the parishes that contribute towards funding youth activity and projects in the area and informed the committee that the youth partnership had successfully applied for and received £9k of Awards for All funding from the Lottery –

- to allow a group of young people to be trained in gardening skills to care for the gardens of residents who are unable to tend to their own gardens.
- And to provide bushcraft, forest school and over night bonding sessions for families (pupils of Lacon Childe school) to build good family relationships.

UPDATE - FUTURE COMMISSIONING AND PROVISION OF YOUTH ACTIVITIES IN CLEOBURY LJC AREA

1. Summary

This report summarises progress and next steps on changes to youth services and activity within the Cleobury and Rural LJC Area.

Following a period of public and stakeholder consultation, the commissioning model for youth activities was developed.

Local Joint Committees (**LJCs**), together with young people and supported by the Community Enablement Team (**CET**), are responsible for commissioning youth activities in their area. A county-wide infrastructure support partner will provide commissioning practice support to LJCs and capacity building support to existing and new activity providers.

LJCs will locally commission youth activity in their areas and will receive SC funding for this. This reflects the council's ambition for LJCs to become local governance structures that enable local councillors, town and parish councils, communities and partners to shape and influence how public money is spent locally and to work with officers in their role as local commissioners.

The provision of youth activities will contribute to the following outcome areas in the Shropshire's Children, Young People and Families Plan 2014:

1. Ensuring all Children & Young People are safe and well looked after in a supportive environment
2. Narrowing the achievement gap in education & work
3. Ensuring emotional wellbeing of Children & Young People by focusing on prevention and early intervention
4. Keeping more Children & Young People healthy and reducing health inequalities

Local outcomes will be developed that reflect the above and the needs and circumstances of the particular area. Outcomes should also be linked to the long term sustainability of provision.

A funding mechanism for future youth activities to respond to specific areas of unmet need in LJC areas has been developed and Cleobury and Rural LJC area has been allocated £2,250 linked to its rural make-up.

2. Recommendation

That the Community Enablement Officer and the Chair of the Cleobury Mortimer Youth Partnership, work with the youth partnership, to bring a grant application that meets with the commissioning outcomes, to the next LJC meeting.

3. Risk Assessment and Opportunities Appraisal

- 3.1 In determining these recommendations the LJC has considered reputational risk and the course of action minimises this risk.
- 3.2 The recommendations contained in this report are compatible with the provisions of the Human Rights Act 1998.
- 3.3 The proposals under consideration will improve the levels of community based and community driven activity in the LJC area.

4. Financial Implications

- 4.1 The funding devolved to the LJC is to be used for youth activities over the year to address local priorities. Funding by the LJC must comply with the general Financial Rules for LJC.
