ACTION

23. Welcome

The Chair welcomed everyone, each member of the Committee introduced themselves and the Chair explained the nature and remit of the Local Joint Committees (LJCs).

24. Receive Apologies for Absence

Apologies were received from Prees Parish Councillor Paul Gill.

25. Disclosable Pecuniary Interests

Members were reminded that they must not participate in the discussion or voting on any matter in which they have a Disclosable Pecuniary Interest and should leave the room prior to the commencement of the debate.

26. Confirm Notes of LJC meeting on 19th October 2016

Clarification was given on para 20. of the previous notes, a question was asked about the number of banners hanging on the front of the Civic Centre. Bev Duffy clarified that Whitchurch Town Council was a tenant of Shropshire Council and the lease states that no banners are to be hung on the front of the Civic Centre.

It was RESOLVED that the notes of the previous meeting held on 19th October be approved and signed by the Chairman as a true and accurate record. Proposed: Gerald Dakin:

27. Partners & Communities Together (PACT)

West Mercia Police

Thanks were passed on from Whitchurch Junior School following the presentation from the Police on internet safety.

PC Deb Wheeler reports that there has been no excessive incidents in the Whitchurch area, listing the following:

- Shed break-ins
- ASB with vehicles speeding/noisy exhausts
- 385 vehicles had been checked and 5 were over the limit, one given a ticket
- s41 issued for noisy exhausts
- s59 warnings were given to 2 drivers

PC Wheeler reminded people to call 101 or report on Facebook 'Shrop Cop' any issues, especially those relating to speeding in the town centre and to give as much information as possible.

Issues were raised about vehicles parking within 10m of a junction, PC Wheeler reported that the Police cannot deal with this and should be reported to Shropshire Council Enforcement Team.

The issue of speeding in the town centre was raised and PC Wheeler reported that she is currently working with the Safer Road Partnership regarding this issue.

Shropshire Fire

Ian Johnson encouraged people to join the retained fire-fighting service due to shortage in numbers. He went on to report that the Whitchurch Fire Station have plans to join with Whitchurch Police.

Shropshire Fire currently have a smoke alarm campaign, contact 01743 260200:

- renew/new smoke alarms
- criteria – home safety risk assessments for the vulnerable and elderly

Whitchurch Fire crew have:

- new equipment – appliances and cutting equipment
- Pet resuscitation equipment had been donated by Leonard Bros.

- A Car Wash Day planned
- Currently 18 retained fire fighters

28. Reporting and Scrutiny (Hot Topics)

(a) White Lion Meadow car park, outside Tesco.

Whitchurch Town Councillor John Sinnott reported that he had visited Shropshire Archives and read the 1958 minute books, from February 1958 to 9 January 1959. White Lion Meadow was purchased by Whitchurch Urban Council from Lloyds and was made into a car park in 1964. Locally it has been mentioned that the people of Whitchurch own the car park, and records show that White Lion Meadow car park was sold to the Council, which was succeeded by North Shropshire District Council and then Shropshire Council, therefore there is conclusive proof that White Lion Meadow is not owned by the people of Whitchurch.

It was also reported that the current lease between Shropshire Council and Tesco states that no charges can be made to park and that the car park is for shoppers only, therefore the new car park signage will have to be changed. A meeting will take place between Tesco, Shropshire Council Planning Department and Shropshire Councillors to discuss this.

Concerns were raised about people working at the Wood Yard, Bredwood Arcade and the swimming pool. It was suggested that the Planning Committee ask for a condition to be put on the planning permission, requesting those that work in these sites to be able to submit their registration numbers to the company operating the Vehicle Recognition Cameras and therefore allowed to park whilst they work.

29. Shropshire Council Update – Neighbourhood Care Model

The aim of the Neighbourhood Care Model is based on long-term work; we need to look after ourselves, get active and keep active. The team presenting highlighted the number of people being diagnosed with diabetes, over 100 per month, and how this number could be reduced.

Shropshire Councillor Karen Calder, Cabinet Lead for Health and Well-being Board talked about the Sustainability and Transformation Plan. This includes Resilient Communities, including care about the community, as well as the Healthy Lives Programme, which includes support for people to help themselves keep fit and healthy.

In Whitchurch there is a Well-being Forum which is supporting the county-wide work on Resilient Communities and promoting the Shropshire Choices website, which is a one-stop web-site with information on adult social care.
