- 4.1 The minutes were agreed as an accurate record of the previous meeting.

5. Big Conversation and Shropshire Council Financial Strategy Update

- 5.1 Mr George Candler gave a power point presentation to the public and committee around the big conversation and Shropshire Council Financial strategy. Members of the public shared concerns about how funding would be found for the key community facilities in Oswestry, GC reassured that the council is doing all it can to find the funds including having conversations with town and parish councils, business' and third sector organisations, exploring options to safeguard services.

Geographical links were mentioned by members of the public. Rural communities use the town facilities, could they also support them financially? Meetings are taking place with all town and parish councils and opportunities to cluster are being explored also.

Mr Vince hunt wanted to say it was not something Shropshire Council chose to do with austerity measures but we have no choice. Being a rural council increases the cost to us per head to deliver and this is not reflected in the payments from government.

- 5.2 Mr Vince hunt thanked Mr George Candler for attending and giving an overview to the LJC of the current situation.
