### 26 Apologies and Substitutions

Apologies were received from Councillors Kevin Turley, David Vasmer (Substitute: Roger Evans) and Sian Lines (Hereford Diocese).

### 27 Disclosable Pecuniary Interests

### 28 Minutes

#### **RESOLVED:**

That the minutes of the meeting held on 17<sup>th</sup> July 2019 be approved as a correct record and signed by the Chairman.

### 29 Public Question Time

There were none.

### 30 Members' Question Time

There were none.

### 31 Chair's Update

The Service Manager, LAC and Care Leavers provided an update on the Care Leavers Covenant and circulated a brief report summarising the event to the Committee.

A Member expressed concern at the percentage of young care leavers that were not in education, employment or training and also at the percentage of young care leavers that were not in suitable accommodation. The Interim Assistant Director of Children's Social Care and Safeguarding responded that these were local and

national concerns and was one of the reasons the Care Leavers Covenant had been established, to provide wider options for young people leaving care. These issues were also looked at by the Corporate Parenting Panel and suggested that a report be brought to a future meeting to examine the issues relating to young care leavers transition into adulthood in more detail. Members agreed this suggestion.

Councillor Cecilia Motley provided an update on the work of the Youth Activities Task and Finish Group. Councillor Motley explained that the work had been intensive, and the Group had received input from West Mercia Police, Shropshire Youth Association and experienced Youth Workers. The Task and Finish Group identified that there was a need for open access provision and outreach access for young people. The proposals put forward were to have a period of transition and to work with Parish and Town Council's and encourage support from them, it was reported that there had a mixed response to date. The Task and Finish Group concluded that outreach workers were needed to meet up with vulnerable children and that these workers were needed wherever children meet. A further report would be presented to Cabinet in December.

The Chairman thanked the Service Manager and Councillor Motley for their updates and for the good work that was being carried out.

### 32 **Children's Services Performance Dashboard**

Members received the report of the Children's Social Care EH&F Specialist, Information, Intelligence and Insight Officer which presented the Committee with Children's Social Care performance measures for Quarter 2 2019/2020.

In response to a question from a Member relating to social worker caseloads and the use of agency workers, the Director of Children's Services and Safeguarding explained that the aspiration was to have social workers with caseloads of no more than 19 – 20, however there were some with caseloads of 25 and it was added that there were plans in place to address this. It was further explained that the reality was that most authorities used agency workers and although there had been quite a high level of "churn" there were steps being taken to reduce this, such as a retention strategy, incentivised recruitment, training and development of existing staff and a trainee recruitment program.

In response to a question relating to the percentage of care leavers in education, employment or training, the Children's Social Care EH&F Specialist, Information, Intelligence and Insight Officer provided further information as to the national averages and brief breakdown of the cohort who were not in education, employment of training and the reasons for this.

#### **RESOLVED:**

That the Children's Social Care Performance measures for Quarter 2 2019/20 be noted.

### 33 Residential Care for Looked After Children

Members received the report of the Interim Assistant Director, Children's Social Care and Safeguarding which presented the Committee with an update on the progress of the Shropshire residential children's homes developments.

In response to a question, the Interim Assistant Director, Children's Social Care and Safeguarding reported that the development had been overseen by a tightly chaired project group and she was extremely pleased to see them nearing completion.

In response to a question relating to neighbourhood engagement, the Interim Assistant Director, Children's Social Care and Safeguarding that feedback had been positive and there had been questions mainly around parking and fencing, there were no ongoing issues or concerns. Councillor Potter commented that as the local member for one of the properties and the neighbouring local member for one of the other properties it was important to keep the engagement going.

Members were pleased to note the update and commented that it was pleasing to note that savings would be achieved but importantly the project was beneficial to those children in need of care.

### 1 Summary

Shropshire Music Service is a valuable cultural and educational asset to the Council. It would benefit from your awareness and support.

### 2 Recommendations

Committee members to:

- Increase their awareness of the work of the Shropshire Music Service and to act as advocates for the service in schools, other settings and the wider Shropshire community.
- Support the Shropshire Music Service by publicising and even attending service events and opportunities.

## REPORT

### 3 Risk Assessment and Opportunities Appraisal

#### Opportunities:

- To increase the number of children taught/amount of time given/additional support offered.
- To work with schools to increase the amount and standard of general music tuition.
- To expand provision outside the education age range – there is already a substantial early years programme, but as yet the service does not offer adult tuition. A pilot programme of singing events for older people in the care system has proved very successful.

#### Risks

The service is at risk if the grant from Arts Council England is cut. It is at risk if there is a fall in families' disposable income, or in school budgets.

#### **4 Financial Implications**

- The service turns over around £1.2 million per year.
- Around £350,000 comes from the Arts Council England grant.
- The remaining income comes from charges to schools and parents.

#### **5 Background**

Countless studies have shown that music education is beneficial to young people. Not only does it promote wellbeing and self-esteem and nurture life skills such as concentration and teamwork, but it is now universally accepted that music education *improves* academic performance.

To ensure the quality of delivery of such a crucial part of children's education, it is important to have a team of highly skilled, experienced and dedicated professionals. Shropshire Music Service is that team.

Formed in the 1960's, the music service is part of the Learning & Skills Directorate in Children's Services. In its early days, the service taught classical instruments to school children individually and provided a youth orchestra for them to attend. It was fully funded by the Council and lessons were free.

Nowadays, the service is fully traded. The service teaches 21 instruments to over 5,000 children each week, in a range of formats including whole class tuition. Pupils are able to attend 18 different bands and ensembles, playing music from all genres.

The service is peripatetic. The service's 60 teachers travel to schools to provide instrumental lessons on brass, strings, woodwind, keyboard, voice, guitar and drums. They also provide classroom music lessons and run groups and clubs.

Whole class instrumental teaching is offered to all schools in the county at a heavily subsidised rate. This means that all children can begin playing an instrument in school at no cost to the family and with an instrument provided for the duration of the tuition. In this way, they ensure that parents' financial circumstances are not a barrier to learning an instrument.

Financial constraints are also addressed by the service's remissions policy, under which disadvantaged pupils can receive up to 50% reduction in fees and instrument hire.

Inclusion has long been one of the top priorities. Shropshire Music Service staff are adept at differentiating music lessons in order to ensure those children with special educational needs and disabilities are not prevented from accessing and excelling in music lessons. In addition, the service is delivering bespoke music provision in SEND settings such as Severndale Specialist Academy and the tuition service.

The service works with schools to ensure the best possible music provision across the board. Continuing professional development is offered to school teachers, both as a staff in their own schools, and centrally with other schools. Visits to schools to deliver free audits of music provision are well received and

often result in an increase in engagement with service. There is an 'open door' policy for support for any aspect of a school's musical life.

Musical instruments can be expensive to buy. The service offers its pupils instrument hire at very low cost, further ensuring that financial background is no barrier to musical progression.

Events are a large part of what makes the service different from individual music teachers. As well as a regular schedule of concerts from their ensembles, they run a very successful calendar of annual events. For example, 'Shropshire Sings' features hundreds of children singing in a massed choir to an audience of thousands.

The service is the lead partner of the Shropshire Music Education Hub, through which funding is received from DFE to deliver the aims set out in the National Plan for Music. This role allows the service to work with a large number of other arts and cultural organisations within the county, helping to ensure our young people have access to a rich cultural experience.

The service is also part of West Midlands Music, a group of 12 music services from around the region, as well as being loosely federated with neighbouring services on Staffordshire, Stoke and Telford. Being a member of these groups allows them to look outside the county to identify best practice and ensure the quality of their provision.

The service's strap-line 'Teaching Music, Changing Lives' reflects the passion they have as an organisation have for music tuition and their belief in its power to transform. Members are most welcome to come and see for themselves: visit their teachers in schools, join their rehearsals with ensembles, events around the county or their regular concerts. Members will be proud of the county's young musicians, and of the organisation that exists to support them.

Music services are under threat across the country. Powys and Wrexham have no provision at all. Once a service folds, the evidence suggests that it is extremely difficult to reform. The service needs your support and advocacy to raise and maintain the profile of the service, thereby helping it to continue and expand.
