1. Summary

Shropshire Council being the authorised licensing authority for:

- The Boars Head, Willow Street, Oswestry, SY11 1AF.

has received an application for a variation of the premises licence at the premises. A location plan is attached to the report as Appendix A.

The application has been accepted as a valid application and during the statutory consultation period relevant representations were made. The application is therefore required to be determined by way of a hearing of the Licensing Act Sub-Committee.

In determining the application, the Licensing Authority must give appropriate weight to:

- the steps that are necessary to promote the licensing objectives;
- the representations (including supporting information) presented by all parties;
- Guidance issued under Section 182 of the Licensing Act 2003;
- Shropshire Council's Statement of Licensing Policy 2019 - 2024.

After considering all the relevant issues the Licensing Authority may grant the application in full or in part, subject to such conditions that are deemed necessary and appropriate. Any conditions imposed must be appropriate for the promotion of the licensing objectives.

Alternatively, the application can be refused if it is considered appropriate for the promotion of the licensing objectives.

Following a hearing, the Licensing Authority should give its decision and provide reasons to support it. This will be important if there is an appeal by any of the parties.

All parties are required to be notified of a decision and that decision should be accompanied by information on the right of the party to appeal.

2. Recommendations

That the Sub-Committee determines the application in accordance with the Statutory Guidance issued under s182 of the Licensing Act 2003, the Council's Statement of Licensing Policy 2019 - 2024, the information contained within this report, supporting documentation and having had due regard to the applicant and the parties/authorised bodies making relevant representations.

That the Sub-Committee determines the application in accordance with the options in paragraph 9.

That the Sub-Committee provides the reasons for its decision.

5. Purpose of Report

To consider an application for a variation of the premises licence at The Boars Head, Willow Street, Oswestry, SY11 1AF.

6. Background

6.1 Marston's PLC have made an application for a variation of the premises licence. Marston's PLC are the premises licence holder and the Designated Premises Supervisor is Jamie Byron.

6.2 The Boars Head has had its current premises licence since November 2005. The premises is located in Oswestry town centre on Willow Street. The premise is surrounded by a mix of residential and other commercial premises.

- 6.5 During the consultation period representation was submitted by Environmental Health in relation to the current conditions in Annex 2 of the licence.

Following a site visit the following conditions were agreed and Environmental Health removed the original representation;

General

- Condition 1 to be deleted as it prohibits entry at an earlier hour which has no impact on the four licensing objectives.
- Condition 2 should be deleted as it is a preamble condition to those beneath it some of which are to change.
- Condition 3 should be deleted as it the occupancy is adequately covered off by condition 7 under Prevent of Crime and Disorder.
- Condition 6 should be rewritten so as to stipulate as follows: “No live music to be undertaken in the rear yard or covered yard after 23:00 hours. Recorded music shall be permitted in the rear yard and covered yard.”

Public Nuisance

- Condition 1 to be removed as provision of notices is covered in condition 4
- Amendment of condition 3 to read as follows: “All external doors and windows shall be kept closed after 23:00 hours other than for access and egress to all rooms when amplified music or speech are taking place”.
- Removal of conditions 5 making reference to fireworks and pyrotechnics.

Public Safety

- Conditions 1 and 2 to be deleted being conditions tendered in 2005 and which are now without merit or enforceability.

7. Representations received (Responsible Authorities)

- 7.1 Representations was received off Environmental Health and withdrawn after agreeing amendments to Annex 2 as above (6.5). Representation has been received of the Police and Public Health, none of these have been withdrawn. These representations mainly relate to the prevention of crime and disorder and Public Safety due to the extra opening hours applied for.

8. Representations received (Other Persons)

- 8.1 Representations has been received from one ‘other person’, in objection to the application. The objectors primary concerns is in respect of the Prevention of Public Nuisance and crime and disorder due to the opening hours applied for and police resources. This representation has not been withdrawn.

9. Options for Consideration

- 9.1 The options available to the Licensing Sub-Committee having considered all the relevant information are as follows:
- To refuse to grant the application

- To grant the application with (or without) conditions in full (or in part)
- 9.2 If the application is to be granted in line with the submitted operating schedule then the amendments/additions and conditions as detailed in paragraph 6.4 of this report would need to be included in the licence.
- 9.3 Additional conditions or restrictions to licensable activities and/or times should only be imposed if considered appropriate for the promotion of the licensing objectives. If other law already places certain statutory responsibilities on a premises, it would not be appropriate to impose similar duties.
- 9.4 Members of the Sub-Committee should be advised that the applicant, licence holder or any other person who made relevant representations in relation to the application may appeal against the decision made to the Magistrates' Court within 21 days of the date on which they were notified.

10. Standard of Decision Making

- 10.1 In accordance with the provisions of the Licensing Act 2003 and the Council's scheme of delegation, all applications where a relevant representation has been made have to be determined by this Sub-Committee.
- 10.2 When determining the application, the Sub-Committee should only consider issues, which relate to the four licensing objectives. The licensing objectives are:
- The prevention of Crime and Disorder
 - Public Safety
 - The prevention of a Public Nuisance
 - The protection of Children from Harm
- 10.3 Members of the Sub-Committee must have regard to the statutory guidance issued under section 182 of the Licensing Act 2003 and the Council's Statement of Licensing Policy. Members of the Sub-Committee may deviate from the statutory guidance and licensing policy only if they deem that there is good reason to do so.
- 10.4 Members of the Sub-Committee should not allow themselves to predetermine the application or to be prejudiced in favour or opposed to the applicant and/or the licence holder and shall only determine the application having had an opportunity to consider all relevant facts.

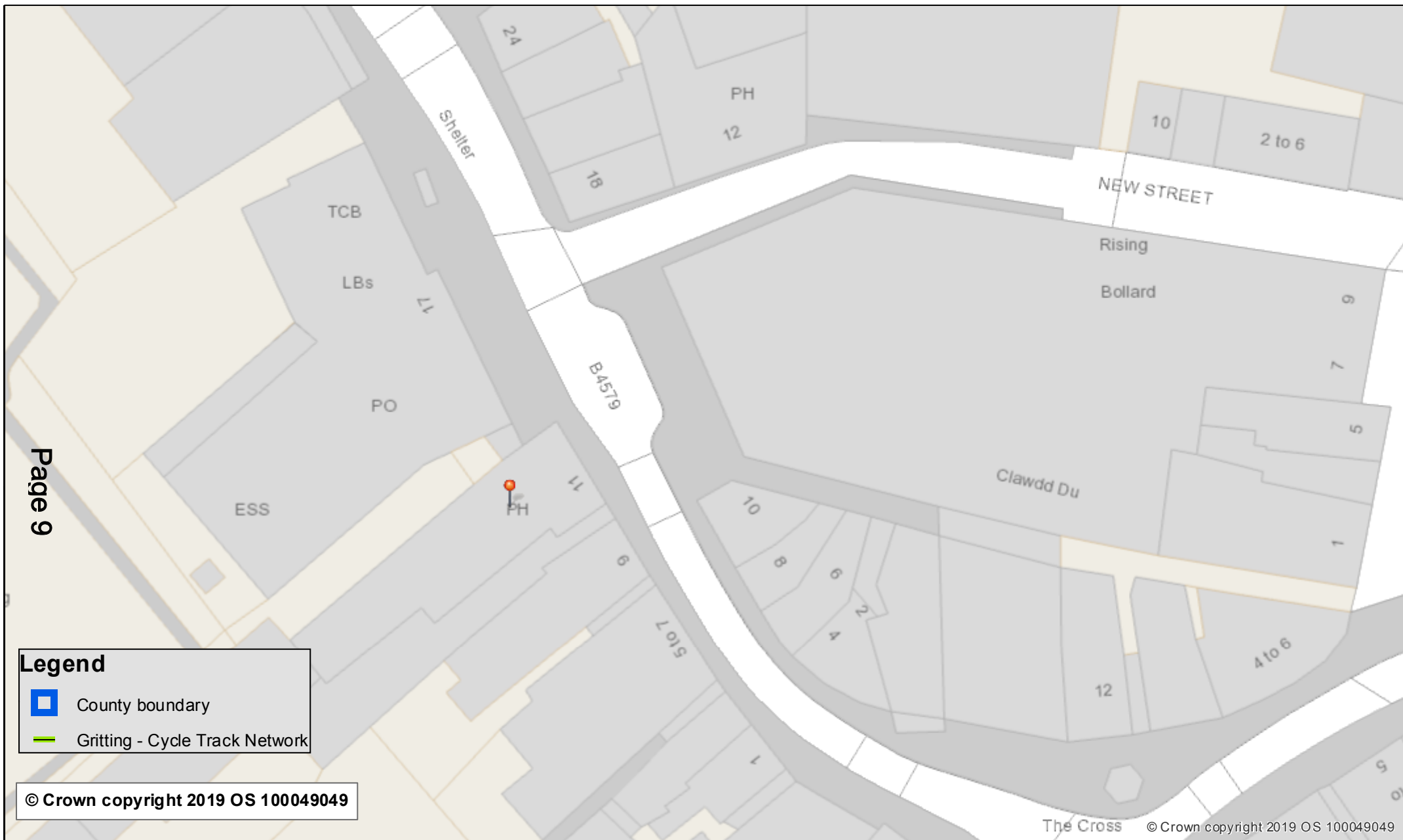
Appendix A – Location Plan

Annexes

Annex 1 – Mandatory Conditions

For the supply of alcohol

No supply of alcohol may be made under the premises licence -

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or their personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of films

For all premises licences and club premises certificate authorising the exhibition of films, access will be restricted only to those who meet the required age limit in line with any certificate granted by the British Board of Film Classification.

Admission of children to the exhibition of any film to be restricted in accordance with the recommendations given to films by a body designated under Section 4 of the Video Recordings Act 1984 - the British Board of Film Classification is the only body so designated.

Door Supervision

Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Authority.

Mandatory Drinks Code Conditions

1. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or,

(ii) drink as much alcohol as possible (whether within a time limit or otherwise); .

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where

that other person is unable to drink without assistance by reason of disability).

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b) an ultraviolet feature.

4. The responsible person must ensure that—

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— .

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml.

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Mandatory Price Conditions

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1—

(a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

(b) "permitted price" is the price found by applying the formula—

$$P=D+(D \times V)$$

where—

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added

Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4.—(1) Paragraph 2 applies where the permitted price given by sub-paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with the operating schedule

General

1. There shall be no curfew on admission after 00:30. Members of the public may be admitted at any time the premises are open to the public.
2. The licensed area now includes the rear yard subject to the following conditions.
3. The total number of persons to be admitted shall not be more than 490 in total with a maximum of 240 inside the main building and a combined maximum in the covered yard and rear yard of 250.
4. At all times when the rear yard is in use, the double width doors leading from the rear yard to the covered yard shall be locked in the open position.
5. At all times when the covered yard is in use, the large doors leading from the covered yard onto Willow Street shall remain unlocked. In busy periods these doors shall be either locked in the open position or shall have door supervisors on duty.
6. There shall be no amplified music in the rear yard other than on a maximum of six occasions per year. A minimum of fourteen days notice in writing shall be given to the Licensing Authority before a live event is held in the rear yard. Such notice shall advise the nature of the event and public entertainment taking place.

Prevention of Crime & Disorder

1. Any person exercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority.
2. Such a person will be employed at the premises at the discretion of the designated premises supervisor.
3. Any person as defined in condition (1) will clearly display his name badge at all times whilst on duty.
4. No customers apparently carrying open bottles upon entry shall be admitted to the premises at any times the premises are open to the public.
5. Where CCTV is installed with recording facilities such recordings shall be retained for a period of 30 days and made available within a reasonable time upon request by the police.
6. Alcoholic and other drinks may not be removed from the premises in open containers save for consumption in any external area provided for that purpose.
7. The maximum occupancy of the main building will be restricted to 240 persons and for the combined covered yard and rear yard 250 persons.

Public Safety

1. The Licence Holder shall comply with the reasonable requirements of the fire officer.
2. The Licence Holder shall comply with the reasonable requirements of the building control officer.

Prevention of Public Nuisance

1. Where appropriate, prominent, clear and legible notices shall be displayed at all exits requesting that the public respect the needs of local residents and leave the premises and the area quietly.
2. Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties.
3. All external doors and windows shall be kept closed other than for access or egress in all rooms when amplified music or speech are taking place.
4. Staff shall be given adequate training to prevent them causing unnecessary noise when they leave the premises and prominent, clear notices shall be displayed at all points where staff and/or customers leave the building instructing them to respect the needs of local residents and leave the area quietly.
5. No fireworks or other pyrotechnics shall be used indoors without the prior consent of the licensing authority.

Protection of Children From Harm

1. No films or videos of any description will be shown so that they can be viewed by persons under the age of any applicable BBFC/Local Authority certification.
2. Children under the age of 16 shall not be permitted to enter the premises after 21.00 hrs.
