#### 7. Visits and Visitor Booklet

One change was made to Rashmika Jogi's contact details.

It was agreed that the booklet would be uploaded to the current SLG for the time being and the clerk will include the link in the weekly email to schools. Fiona Moss suggested adding virtual visits/visitors – Birmingham, Liverpool – and agreed to send a list to the chair. Other colleagues agreed to suggest other recommendations.

Simon Nightingale advised that he is undergoing training for primary education.

Steph Shirra advised that she had some artwork that could be added to update the front cover.

#### 8. Shropshire Learning Gateway

There were no updates at this stage but John Rowe is working on this. The existing SLG continues to be used in the interim period.

Agreed Syllabus – SACRE members will be providing a response to questions.

Steph Shirra is picking an area from primary - L9 – How should we care for the world and for others and why does it matter? (KS1). She will provide three sub-questions and tips for talking to KS1 and this will link to teaching and learning approaches. The video will be three minutes maximum/400-500 words.

Fiona Moss felt a thematic approach would be better and this was agreed. The chair will make a selection from secondary Eg How far does it make a difference if you believe in life after death? The same timing limits will apply.

Mark Harrington suggested qualifying by saying 'this person's view'.

Simon Nightingale advised that Zoom works well for creating videos or colleagues could use their phones (landscape).

The videos would need to go on YouTube.

The deadline for this work was agreed as the Autumn term meeting.

The chair agreed to circulate some guidance.

## 9. RE Hub Meeting

Steph Shirra reported back from the primary hub. There are eight members and an initial face to face meeting was held to set this up. All are positive about the new syllabus. Termly meetings are planned with emails in between. Examples of work will be brought to the autumn term meeting.

Recorded/evidence and assessment have been highlighted as a concern.

#### 10. Education Bill - Fiona Moss

The biggest focus is academisation (into MATs) by 2030 with work on educational standards being removed from LAs who will focus on safeguarding, admissions/transport and SEN.

There is a new set of academy trust standards which are wide ranging. The Secretary of State has more powers.

LAs can now initiate trusts.

There are concerns about where SACREs will sit.

The secondary meeting focussed on planning for the new syllabus and supporting a new HOD.

In primary, one SDG had requested a session which was provided.

There were 17 people online for the focus last week on multi-disciplinary RE.

Mark Harrington added that in the few Ofsted inspections, schools have been challenged on diversity.
