31 Welcome and Apologies for Absence

- 31.1 The Chair welcomed Harriet Halliday, Dominic Bowyer and Rachel Lambert-Jones to their first meeting of the Partnership.
- 31.2 Apologies for absence had been received from Jim Bunce (Long Mynd Adventure Camp), Adrian Cullis (Individual Member), Rob Harris (Land, Life & Livelihoods), Cllr Carolyn Healy (Telford and Wrekin Council), Cllr Dan Morris (Shropshire Council) and Jenny Rouquette (Shropshire Good Food Partnership).
- 31.3 The National Landscape Team Manager advised the meeting that Sarah Bury had stepped down as the representative of the CPRE and welcomed Sue Steer as her replacement. He reminded members that Mrs Bury had been a long serving member of the Partnership serving two separate terms firstly as the representative of South Shropshire District Council and then as an Individual member during which time she had been Chair of the Partnership and then more recently as the representative of CPRE.
- 31.4 The National Landscape Team Manager reminded members that following the biennial review there was a vacancy for an organisational member and advised them that he had received a formal application from the Shropshire Geological Society following expressions of interest from three organisations. He stated that he would circulate the application to members by email for them to approve.
- 31.5 The National Landscape Team Manager advised the meeting that there was a vacancy for a Vice-Chairman following the sad death of Councillor Chris Turley. He asked any member that wanted further information to contact the Chair or him.
