However, it is not accepted that it is solely the responsibility of the licensing authority to provide evidence of risks including potential risks (which are different from perceived risks) to the licensing objectives; in fact, officers are of the view that operators have an equal responsibility to identify and mitigate against potential risks.

Findings from a quick scoping review Heather Wardle, Gambling and Place Research Hub 13 th July 2015'.

Doc 1	20	In Part	Consultee has referred to Paragraph 17.4, however it appears that the comments made are relevant to Paragraph 17.5. The policy does not specify any area where gambling premises should not be located; however, the local area profile may identify in the future such areas but these will be wholly evidence based and dealt with on a case by case basis. Paragraph 17.5 has been amended to make it clear that refusal of an application will be based on evidence of risk to the licensing objectives together with ways in which these can be mitigated through appropriate conditions.
Doc 1	21	In Part	The originally drafted Paragraph 17.6 was not a misunderstanding of the operation of betting premises; it was intended to bring policies around preventing underage sales of age restricted products/services in line with the requirements of 'Challenge 25'; this is a nationally recognised policy aimed at preventing many types of underage sales not only those under the Licensing Act 2003. However, Paragraph 17.6 has been amended to acknowledge the Gambling Commission's current position. (It is the intention that officers will raise this matter with the Gambling Commission for further consideration on the basis that officers are of the view that 'Challenge 25' ought to be the standard that applies to all policies aimed at preventing age restricted sales.)

Doc 2	2	In Part	Paragraph 17.1 sets out that the Council is likely to reject an application or revoke an existing licence or permit where there is insufficient emphasis placed on the provision of information to support vulnerable persons and problem gamblers. It is not appropriate for the Council to specify how an operator ought to provide the information; the emphasis is on the operator to set out how it will achieve this and for the Council to then determine whether this is sufficient to satisfy the licensing objectives. Policing the compliance with conditions is a role for the Council. With respect to 16 and 17 year olds the focus is on preventing access to gambling activities rather than providing information/advice.

Doc 2	4	N	The whole policy is aimed at reducing the risk of gambling becoming an addiction. However, the law requires the Council to 'aim to permit' gambling activities. It is not the role of the Council to support those with gambling addictions and in this respect the Council's position is set out at Paragraph 17.8.
