1. Summary

- 1.1 NHS England working with Shropshire and Telford & Wrekin, health and care organisations, commissioned the development of an action learning programme to explore the needs of carers.
- 1.2 As part of the development of a multi-agency, multi-disciplinary action learning programme, story-telling was utilised as a research methodology in both the qualitative analysis of focus groups (4) and narratives (26) of key HSC stakeholders, comprising a mixture of carer representatives and HSC professionals. The aim of this programme was to explore how co-production may inform collaborative decision-making and joint planning for carers.
- **1.3** The narratives (story telling) were used as a way of understanding carers' experiences in order to support and influence decision making.
- **1.4** The focus groups were used to determine current stakeholder practices regarding carer support, along with understanding perceptions that may contribute to the development of a multi-agency way of working framework, and whether this methodology could be utilised for the development and generation of evidence.
- **1.5** The result is the attached report (Appendix A); Development of a multi-agency, multi-disciplinary learning programme based on 'story-telling' learning from patients, carers and staff
