Mental Health Transformation

In Shropshire we are developing **new models of accommodation** to support people to live in communities and prevent hospital admissions in collaboration with our partners in Housing, the NHS and voluntary agencies.

The largest part of the mental health transformation programme focuses on the transformation of community mental health services to integrated working.

Covid has had a huge impact on mental health which is still being realised. In response, we have prioritised the expansion of the CYP crisis service in 2020/2021, ahead of plan, and this service is now operational.

We will undertake **joint commissioning** across mental health and alcohol/drugs (including primary care, criminal justice settings and specialist/acute care), supported by strong, senior, and visible leadership.

Joint Commissioning

Collaborative **Commissioning Opportunities**—Place based Joint Commissioning to drive efficiencies and system savings and quality outcomes.

Health and social care to jointly review agreements and costs of specific contracts and consider options to tender/contract these differently and jointly, in particular those high-cost complex services.

To scope a **shared Provider Framework** to deliver on specific health needs, specifically for joint care packages.

Provider Market Transformation

- Shropshire, Telford and Wrekin LA's, along with the CCG have developed a **new process for commissioning care** and supported for adults with Learning Disability, Autism or Mental Health needs.
- We have redesigned our **direct payments policy** and re launched the offer of direct payments as an alternative to commissioned care and support.
- We have recently worked with Telford and Wrekin to procure a digital platform, Care Cubed –
 accurately assess the cost of complex care packages for adults with a learning disability.
- We implemented **standard rates** for Older Persons and Physical Disability care homes to work towards a fair, transparent and equitable market, that can remain vibrant and stable.
- To review and publish Shropshire Market Position Statement.
- We are currently delivering an Assistive technology project into our supported living schemes, proving individuals with digital technology that will assist them to live more independently.
- We are working with care home providers to encourage them to diversify into outreach care and support, particular in our more rural locations where we struggle to source care.

Different Model for Temporary Accommodation

- To decrease the number of B&B placements and provide supported temporary accommodation
- Increase homeless prevention options
- To implement the Domestic Abuse Bill
