PARK HOMES AT THE CLIFF PARK HAVE VERY THIN WALLS (I CAN HEAR MY NEIGHBOUR COUGH OUTSIDE) MANY RESIDENTS ARE ELDERLY AND VULNERABLE, SOME WITH SLEEP AND MENTAL HEALTH ISSUES. TO HAVE A NEIGHBOUR FROM HELL LIKE THIS WOULD BE INTOLERABLE, VERY CRUEL.

TO PREVENT CRIME & DISORDER I COULD FORSEE THIS ENCOURAGING DRUG TAKING AND ROWDINESS AS GROUPS MADE THEIR WAY HOME THROUGH TOWN IN THE EARLY HOURS WITH POTENTIAL FOR DAMAGE TO CARS^{etc}.
