THE PREVENTION OF HARM TO CHILDREN

TO PREVENT PUBLIC NUISANCE

The hours requested by this licence and the types of entertainment suggested make it inevitable that there will be too much noise for a residential area.

TO PREVENT CRIME & DISORDER

The application suggests that ALL events will be stewarded but no numbers are given. It states that bad and drunken behaviour will lead to participants being ejected. One might ask where to? Obviously into a quiet residential neighbourhood and next to the children's playground.

PUBLIC SAFETY

The numbers suggested will bring an immediate and intolerable increase in traffic. The Linney is a single lane road for part of its length with houses right up to the road. Satnav followers already cause extreme problems
