- A representation can be made against an application for a premise to carry on a licensable activity within the 28 day consultation period. Representations can also be made on premises that are making variations to an existing licence.
- Representations are made by:

THE PREVENTION OF HARM TO CHILDREN

The events proposed within the license application will result in a huge and unacceptable increase in traffic along the Linney adjacent to the children's playground. This will increase the risk of accidents to children.

The increased alcohol consumption and drunkenness in the area will also put children at risk.

TO PREVENT PUBLIC NUISANCE

- 1) Increased drunkenness. The supply of alcohol for consumption on and off the premises Mon- Sun 08:00 to 01:00 and late-night refreshments 23:00 01:00 daily, and to 02:00 on special occasions at the Ludlow Rugby Club, in itself constitutes a public nuisance. Large quantities of alcohol will undoubtedly be consumed leading to drunkenness and an increase in drink driving on the Linney and on local roads providing access to the club.
- 2) Unacceptable noise levels. The license extension is to allow outdoor entertainment specifically stated to include plays, films, live music, recorded music, performance of dance and anything similar to live, recorded music or dance. Noise from these activities will be heard by all properties in the Linney and Dinham. These activities and associated noise levels are totally inappropriate to a residential conservation area.

 From our property at South Lodge we hear ALL current noise from the rugby pitch loud and clear. This is just about tolerable during daytime hours and the occasional early evening. For it to go on until 1am on a daily

basis, and on some occasions to 2am is totally unacceptable.

The application says noise will be kept to a level where it can't be heard by local residents inside their homes with their windows shut. This is laughable and totally unacceptable. Who in Dinham is going to sit inside on a hot sunny June evening with all their window closed?

In addition, noise from the sports pitches below the castle reverberates off the castle halls and is magnified. The converse is all true. Noise from events held WITHIN the walls of Ludlow Castle are contained and reduced.

3) Increased traffic and pollution levels. The only access road to the rugby club is the Linney. This is single track in several places where it is constrained by high stone walls. Driving on the Linney frequently involves several cars reversing some distance until a passing place can be found to make way for an oncoming car. The situation is exacerbated with the many delivery vans and lorries who use the Linney. A reasonable estimate of the number of cars generated by the proposed 6000 visitors a day (even if some came by train) might be 2000. Its impossible to imagine 2000 cars successfully navigating the Linney to reach the rugby club. The Linney would become impassable to local residents.

The pollution produced by hundreds of cars in stationary traffic would degrade the air quality of the area around the Linney and would be totally unacceptable.

TO PREVENT CRIME & DISORDER

The problem of teenage disorder in Ludlow will be aggravated with the availability of a venue supplying alcohol all day long until 1 am.


PUBLIC SAFETY

The increased alcohol consumption has the potential for more driving over the limit leading to more road accidents.

Thank you forwarding my representations to the applicant.

I would like to add that in terms of public nuisance our property South Lodge in Dinham SY8 2JE is only 210 metres from the rugby pitch. Our garden is a mere 140 metres from it. We hear every sound from rugby training and rugby matches inside our house with the windows closed. Noise from live events would be intolerable.

The red line on the attached map shows how close the pitch is to our house. Other houses on the Linney are similarly close.

I would appreciate if you could forward this additional information to the applicant.
